Congratulations on your retirement!

Your dedicated service in the government has earned you a package of GSIS benefits and privileges that you can enjoy now and in the future.

These include the following:

- 1. Cash Surrender Value.** This is the amount of money that you, as a policyholder, will receive for the termination of your GSIS life insurance policy before its maturity. Like your retirement benefit, the proceeds are credited to your e Card account.
- 2. Monthly Pension**
 - If you chose the 18-month cash-payment retirement option, you have to enroll for the pensioner's e Card to enable us to start crediting your monthly pension. GSIS pension is credited on the eight day of every month in the pensioner's e Card or UMID card.
 - If you availed of the five-year lump sum retirement option, you need to apply for resumption of pension one month before the end of five years from date of retirement to start enjoying your monthly pension.
- 3. Pension Loan**

Old-age pensioners may apply for this loan through the GSIS Wireless Automated Processing System (GWAPS) kiosk. The loan proceeds may also be withdrawn from any ATM using your eCard or UMID card.

The amount you may borrow will depend on your age. The loan is payable in two years and may be renewed after it has been paid in full. Since it is covered by a loan redemption insurance, the balance will be deemed fully paid in the event of your demise.
- 4. Christmas cash gift and pension increase**

These benefits are granted to all old-age and disability pensioners with at least 15 years of service.

If you retired with an 18-month cash payment and immediate pension, you will enjoy the Christmas cash gift and pension increase five years after receiving your pension.

If you retired with a five-year lumpsum, you will be entitled to these benefits five years from the date of your retirement.
- 5. Funeral and Survivorship Benefits and the subsequent transfer of monthly pension to your surviving legal spouse (50% of your pension) and minor/incapacitated children (10% of your pension).**

Please keep in mind that because these benefits have a prescriptive period, application should be submitted within four years from the pensioner's demise.
