





HIGHLIGHTS

Lionheart Farms (Philippines) Corporation (LFPC) seeks to conserve the remaining forest through protection, reforestation of denuded areas, assisted natural regeneration (ANR) of remaining forest, and secure the protection and maintenance of planted trees.

The Forest Protection project also aims to achieve the following:

- (1) Compliance with the JVA requirements;
- (2) Strengthening existing collaboration(s) with the MENRO, PCSD, DENR, Municipal LGU, and Local Government Units (LGU) of Ransang and Candawaga, Rizal and other local communities and partners especially with the protection and reforestation of the denuded forest;
- (3) Supporting the National Greening Program of the Government (NGP);
- (4) Further enhancement of the awareness and capabilities of the local communities in the protection, reforestation of denuded forest and establishment of endemic fruits & trees, and high value fruit tree plantation;
- (5) Effective mobilization of local communities towards the protection of the remaining forest and establishment of high value fruit tree plantation; and
- (6) help improve the living condition of IP's and non-IPs through the promotion of raising the indigenous tree and fruit tree seedlings.

For this month of SEPTEMBER 2022, the Lionheart Farms (Philippines) Corporation (LFPC) has accomplished the following activities:

- a. Last September 2022, Lionheart Farms (Philippines) Corporation's continued conducting Seedlings Care and Maintenance inside the Forest Tree Nursery area. The following activities were conducted are watering, weeding, application of organic foliar fertilizer, pesticide and fungicide, sorting and hardening. *(Please see photos attached as ANNEX A)*
- b. Last September 2022 the Lionheart Farms (Philippines) Corporation (LFPC) personnel continue undertaken of Seedlings Production. The personnel assigned was collected of Mahogany (*Swietenia macrophylla*) wildlings with a total of one thousand two hundred thirty (1,230) pieces. Those seedlings collected




transferred immediately to the polybags to reduce the seedlings mortality at the same time application of foliar fertilizer and fungicide was applied. *(Please see photos attached as ANNEX B)*

- c. Last September 2022, Lionheart Farms (Philippines) Corporation's Foot Patrol Unit continued conducting regular on-site monitoring of illegal activities inside the JVA and adjacent areas. And as of this month, there is no trace of illegal activities such as poachers of wildlife as well as illegal loggings monitored in the vicinity and neighbors of the Agroforestry Development Project areas, that's because of the presence of the CENRO, KSK staff and Barangay and also the Foot Patrol/monitoring team of the company. *(Please see photos attached as ANNEX C)*
- d. Last September 13, 2022, Lionheart Farms (Philippines) Corporation conducted a tree planting activity. This activity was marked as Mr. Ferdinand Romualdez Marcos Jr. birthday celebration our beloved President. The planting was held at Nursery area in Lower Malutok, Ransang and Coconut Factory in Culasian, Rizal, Palawan. The tree planting activity headed by President Mr. Christian E. Moeller and Vice President Maria Cecilia C. Moeller together with Lionhearts Farms Philippines Corporation's employees from a different Departments and collaboration of Community Environment and Natural Resources Office (CENRO), Philippine Army and Tribal Leaders. A total of one hundred thirty-one (131) Golden Showers (*Cassia Fistula*) Seedlings were planted. Forty (40) seedlings were planted at Coconut Factory in Culasian and ninety-one (91) tree seedlings and 20 bamboo seedlings planted in Forest Nursery area at Barangay Ransang, Rizal, Palawan. *(Please see photos attached as ANNEX D)*




- e. Last September 2022, Lionheart Farms (Philippines) Corporation planters team were planted of Bayog (*Dendrocalamus merrillianus*) Seedlings at Sitio Malakalaka, Campong-Ulay, Rizal, Palawan. A total of two hundred fifty (250) were planted at the said area. *(Please see photos attached as ANNEX E)*

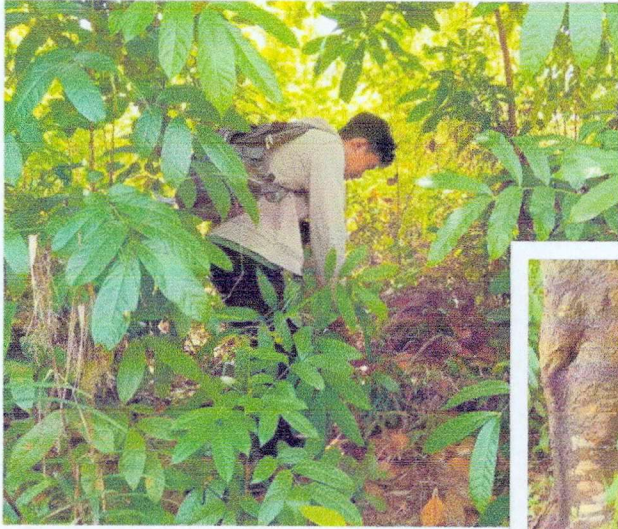

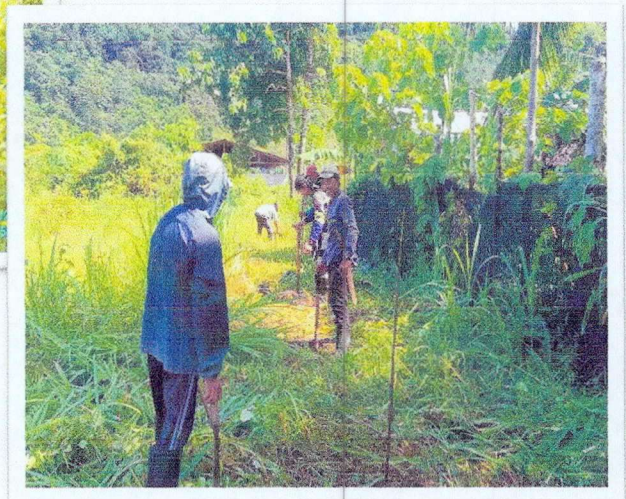
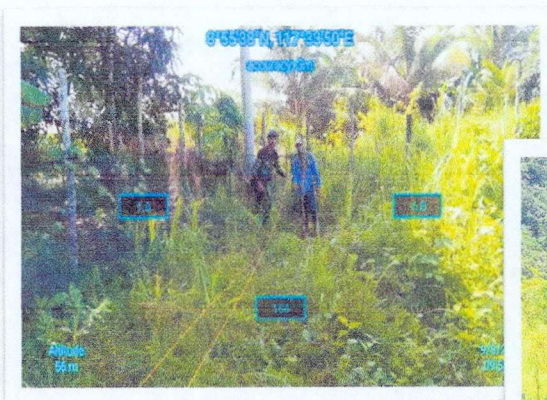

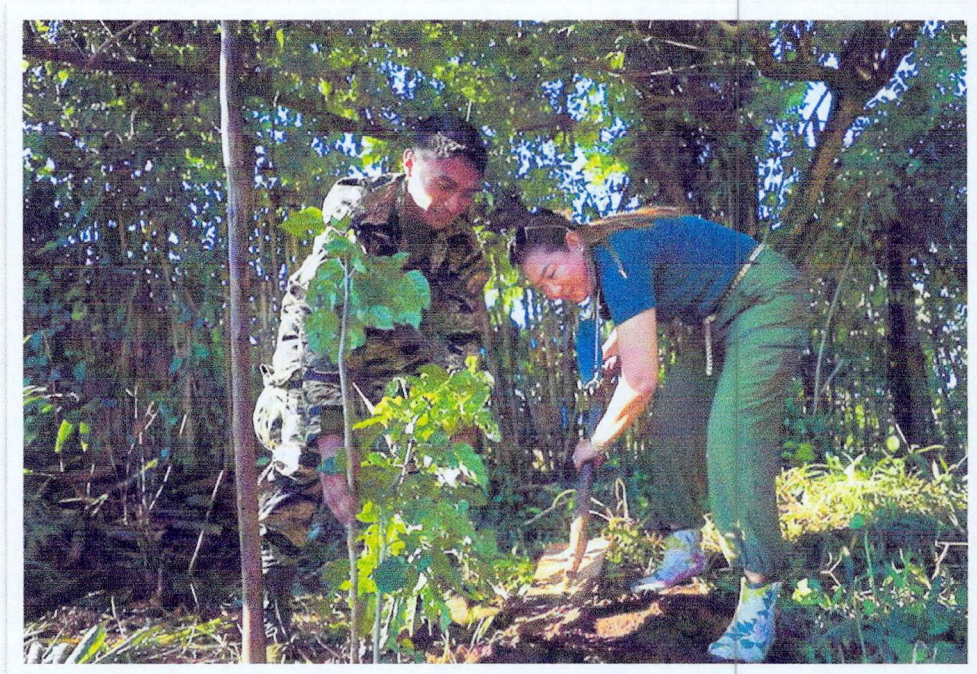
