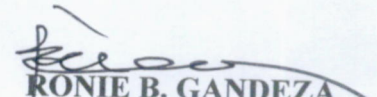

Based on DENR DAO No. 2008-22 the following documents are the requirements for DENRO:

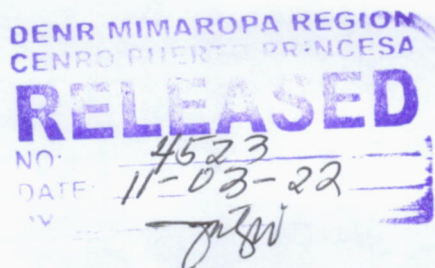

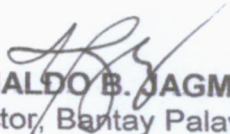

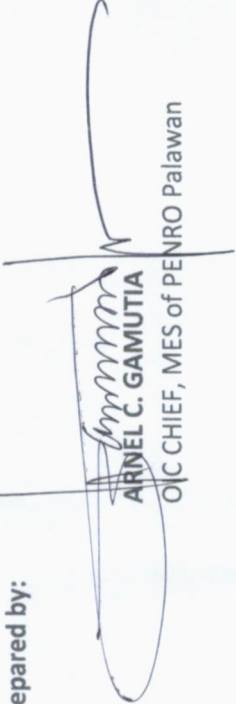
