

In connection with the above-subject, I have the honor to report the following to wit:


- 1. That on October 11, 2022, Jennifer Torio filed a letter request in this office for titling of lot no. 2214,PIs-33;
- 2. That based on the allocation book of this office, lot no. 2214, PLS-33 with an area of 7.8186 hectares was first applied by Leoncio Casidsid with an existing homestead application no. 9-2791 dated May 24, 1956.
- 3. That based on the ocular inspection conducted in the premises on October 1, 2022, it was found that the area inspected is actually occupied by Dave Guiller Torio, Jennifer Torio, Erickson Torio and Mark Joseph Torio since 2021. The improvements found are trees such as Gmelina Trees, Sampaloc Trees, Bamboo Trees and Sinegwelas Trees, there is also a mini hut and the area is hilly.
- 4. That as per Brgy. Certification dated September 29, 2022, that Jennifer Torio, Dave Guiller Torio, Erickson Torio and Mark Joseph Torio is the actual occupants of lot 2214 located at Brgy. Sta. Teresa, Magsaysay, Occ. Mindoro.
- 5. That on January 16, 2021, heirs of Leoncio Casidsid relinquished, cede, transfer and convey all their rights and interests over the said parcel of land to Erickson Torio, Dave Guiller Torio, Jennifer Torio and Mark Joseph Torio in a public instrument of Deed of Relinquishment of Rights and Interests. - 6. That as per projection based on Geotagged photos taken in the area, it appears that the said lot falls within Alienable and Disposable as per Land Classification (LC) Map 600, Project 9-A, Blk XII certified on January 6, 1926, the lot no. 2214, Pls-33 is within Alienable and Disposable Land; (Attached is the copy of A and D Certification)


