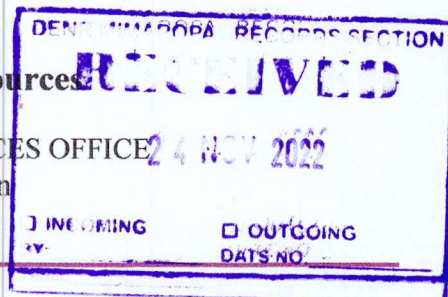

Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated October 19, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on April 06, 2022 by the Enforcement Officers of CENRO Taytay, Palawan while doing patrolling activities and unexpectedly found the piled of lumbers in the area of Sitio Barok, Barangay Cataban, Taytay, Palawan. No one seen within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.

The Team apprehended the twenty-two (22) pieces (103.66 board feet) lumbers of Apitong and Malamangga species of different dimensions with estimated fair market value of Php6,219.60.

The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station II at Barangay Bagong Bayan, El Nido, Palawan for proper safekeeping under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.

Notices to the public dated April 11, 2022, April 11, 2022 and April 25, 2022, were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notices of hearing were sent to all concerned parties and finally on August 26, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.

We concur with the CENRO recommendation for the issuance of confiscation order of the apprehended forest product in favor of the government.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

**WHAT**

This is the final report on the administrative adjudication of the twenty-two (22) pieces of lumber of Apitong and Malamangga species equivalent to one hundred three point sixty-six (103.66) board feet.

**WHEN**

The interception/recovery took place last April 6, 2022 and the corresponding report was submitted and received in the Office on April 7, 2022 (Annex A to A<sub>1</sub>) plus the geo-tagged pictures (Annex B), and Apprehension Receipt (Annex C to C<sub>2</sub>).

**WHERE**

The forest products were recovered in Sitio Barok, Barangay Cataban, Taytay, Palawan and brought to Forest Product Monitoring Station II at Barangay Bagong Bayan, El Nido, Palawan.

**WHO**

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were personnel from the Forest Product Monitoring Station (FPMS II) composed of then Forest Ranger Gerald J. Namoc as Team Leader along with ENTMRPA Park Rangers.

**WHY**

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

**HOW**

Forest Protection Officer Janseen Del Rosario and the team conducted surveillance and monitoring at the aforementioned barangay due to the complaint that there is an illegal kaingin somewhere in the area. On the ground, the team unexpectedly found the piled illegal cut lumber covered with dried leaves of trees and twigs from the national road. Minutes passed, the team



then seized the lumber and declared it abandoned. The items using personal topdown were hauled to Forest Product Monitoring Station at Bagong Bayan, El Nido.

**Adjudication procedure**

Seizure Receipt (D) and Seizure Order (Annex E to E<sub>2</sub>) and were facilitated on April 11, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of six thousand three hundred nineteen point six (6,219.6) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on April 11, 18 and 25, 2022 (Annexes F to F<sub>2</sub>). The Certification of the Records Officer dated May 2, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex G).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Technician I Gerald J. Namoc et. al, and Punong Barangay Jon O. Tumampil of Barangay Cataban, Taytay, Palawan to a hearing on 26<sup>th</sup> day of August, 2022 at 3:30 in the afternoon (Annex H to H<sub>1</sub>).

The examination pushed through as evidenced by the Attendance Sheet (Annex I). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked the *Apprehending Officer* on place where lumber was brought for safekeeping. *Forest Technician I Namoc* answered that they brought the items to the nearest station which is the FPMS II at Bagong Bayan, El Nido, Palawan and conducted investigation after the incident. *HO* inquired about conducting IEC on the area and *FT I Namoc* replied that they conducted information dissemination in relation to PD 705. Without further clarifications, *HO* then adjourned the hearing.

Transcript of the minutes is Annex J.

**Conclusion and recommendation**

The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.

This report is respectfully submitted pursuant to the memorandum of the Undersecretary for Field Operations, Enforcement and Muslim Affairs dated July 01, 2020.

**WHAT**

This is the report of the apprehended Twenty-two (22) pieces of abandoned Apitong and Malamangga lumber with different dimension and aggregate volume of 103.66 board feet.

**WHEN**

The apprehension be done on April 06, 2022 at around 09:30 o'clock (in the morning) and corresponding report was submitted and received in the Office on April 07, 2022 along with the geo-tagged photos and Apprehension Receipt with Tally sheet.

**WHERE**

The apprehension took place in Sitio Barok at Barangay Cataban, Taytay, Palawan and the said allegedly illegal cut lumber was brought by the apprehending team to the nearest station in the Forest Product Monitoring Station FPMS-2 Bagong Bayan, El Nido, Palawan for safekeeping and further investigation.

**WHO**

There is no probable offender in the said area, and the enforcement personnel apprehended of (22) pieces of abandoned Apitong and Malamangga lumber with different dimension are Forest Protection Officers Janseen Del Rosario, Romnick Juan, Danilo Moreno, Jezrel Dalojo, Serville Loberto (volunteer) and newly one hired FPO charge from Liminangcong.

**WHY**

The said forest product was taken and seized in violation to **Section 77 of Presidential Decree 705 as amended** otherwise known as Revised Forestry Code of the Philippines as stated as "Any person who shall cut, gather, collect, or remove timber or other forest product from any forest land, or timber from alienable or disposable public lands, or from private lands, without any authority, OR POSSESS TIMBER OR OTHER FOREST PRODUCTS WITHOUT THE LEGAL DOCUMENTS AS REQUIRED UNDER EXISTING FOREST LAWS AND REGULATIONS, SHALL BE PUNISHED WITH THE PENALTIES IMPOSED shall be guilty of qualified theft as defined and punished under Article 309 and 310 of the Revised Penal Code);

## HOW

Forest Protection Officer Janseen Del Rosario and company conducted surveillance and monitoring place in Sitio Barok at Barangay Cataban, Taytay, Palawan because of complain from concern citizen that there is illegal kaingin somewhere at the said area. But unexpectedly they found-out allegedly some piled of illegal cut lumber covered by dried leaves of trees and twigs distance from national road. After a while, the apprehending team decided to seized the item also allegedly illegal cut lumber and proclaimed as abandoned.

The undocumented forest product was hauling thru using personal top down of Mr. Serville Loberto and brought to the nearest station in the FPMS-2 station at Barangay Bagong Bayan, El Nido, Palawan for safekeeping and further investigation.

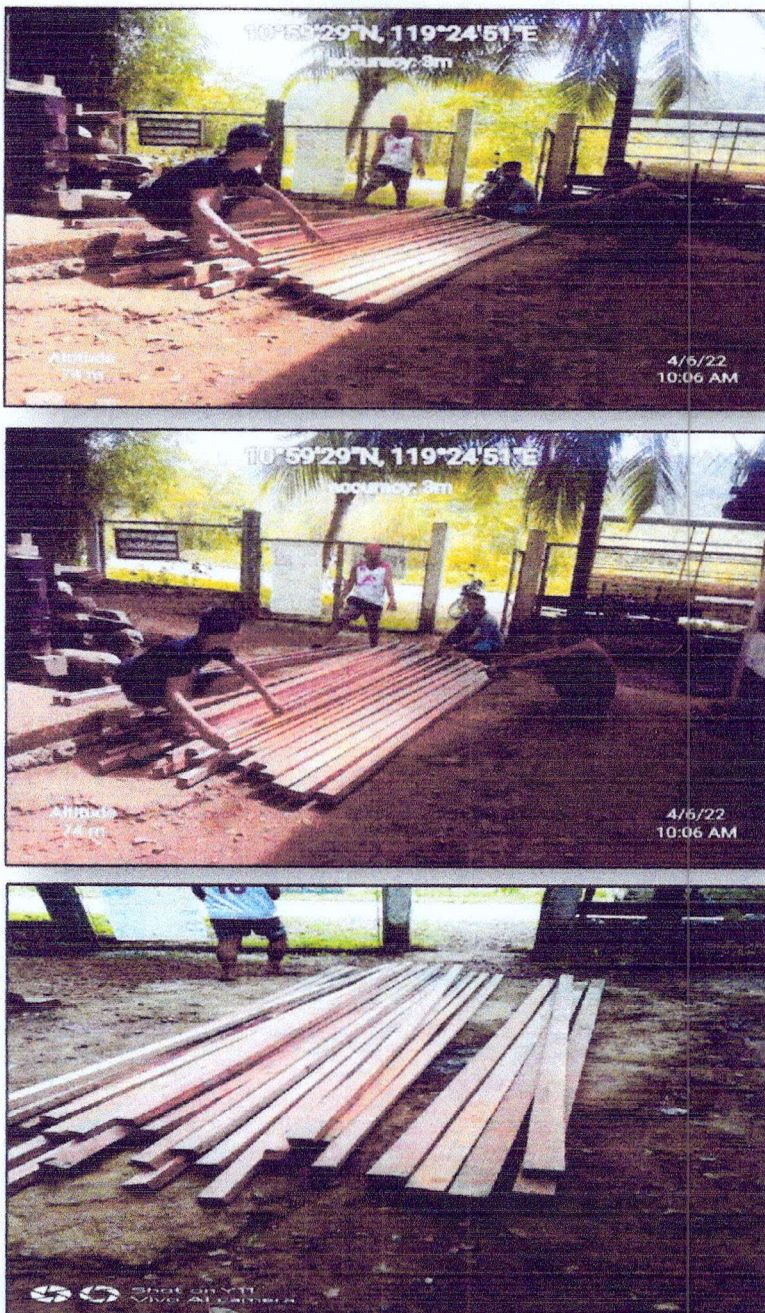


Figure 1. Pictures shown above are the lumber already in FPMS station 2 for safekeeping and further investigation.
