SUBMISSION OF MINUTES OF ADMINISTRATIVE HEARING ON APPREHENSION AND SEIZURE OF ONE (1) UNIT MULTICAB BEARING PLATE NUMBER FER 447 LOADED WITH UNDOCUMENTED GMELINA LUMBERS HAVING A TOTAL VOLUME OF 259.83 BOARD FEET AT BARANGAY ALFONSO XIII,

QUEZON, PALAWAN WITHOUT LEGAL DOCUMENTS

Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated October 25, 2022 relative the above subject.

Per memorandum, the apprehension was made on August 02, 2022 at around 11:50 P.M. by the personnel of PNP Quezon MPS while conducting patrolling activities around Poblacion area of the municipality of Quezon using their Patrol Car. They noticed a Multicab loaded with lumbers along National Highway, Sitio Underground I, Barangay Alfonso XIII, Quezon, Palawan. After verification and interrogation, the PNP team arrested the persons involved and apprehended the twenty-one (21) pieces (259.83 board feet) lumbers of Gmelina species. The estimated fair market value of the Multicab is Php150,000.00 and the 259.83 bd. ft. lumbers of Gmelina is Php6,495.75 respectively.

The perpetrators were identified as Bernie Escovidal Masucol (Driver/Owner of Multicab and Lumbers), Ronnie Escovidal Masucol (Helper). Both are residents of Barangay Alfonso XIII, Quezon, Palawan. The transport of Gmelina lumbers without pertinent permits from DENR is a violation of Section 77 Presidential Decree No. 705, as amended. The PNP Quezon filed a criminal complaint before the Office of Provincial Prosecutor against the suspects on August 24, 2022 with NPS Docket No. IV-08-INV-22H-0997.

The apprehended items were hauled, properly turned-over and deposited at DENR CENRO Quezon compound, located at Barangay Alfonso XIII, Quezon, Palawan under the custody of Forest Technician II Armando J. Batayo for safekeeping purposes. The notices of hearing dated September 22, 2022 and September 27, 2022 were sent to all concerned parties in relation to DAO 1997-32. The administrative hearing was conducted on October 04, 2022 at DENR CENRO Quezon, Palawan.

We concur with the CENRO recommendation for the issuance of confiscation order of the apprehended conveyance and forest product in favor of the government.

Submitted herewith the minutes of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on October 4, 2022 at DENR-CENRO Quezon, Palawan.

Please be informed that prior to the conduct of hearing, a notice of hearing was given to the respondents informing them of their privilege to exercise their rights to hire a legal counsel of their own choice pursuant to the provisions of the New Constitution of the Philippines. However, despite the considerable period of time since the notice of hearing was served, this office did not received any notice or motion from the respondent to re-schedule the hearing due to non-hiring of lawyer.

Further informed that during the scheduled date of hearing, the respondent asserted to proceed the hearing even without the assistance of their own legal counsel.

I. FACTS OF THE CASE:

WHAT:

Apprehension and seizure of 259.83 board feet Gmelina lumbers.

WHEN:

On or about 11: 50 PM of August 2, 2022

WHERE:

Sitio Underground 1, Brgy Alfonso XIII, Quezon, Palawan

WHO:

Bernie Escovidal Masucol, driver/owner of multicab and lumbers, Mr.

Ronnie Escovidal Masucol, helper, both are residents of Bgy. Alfonso XIII,

Quezon, Palawan.

HOW:

On the evening of August 2, 2022, PLT John Rhain P. Baza and PSSg Donato B. Abog, members of PNP Quezon MPS while conducting patrolling around Poblacion Quezon using their patrol car had noticed a multicab loaded with lumbers along national highway at Sitio Underground 1, Bgy. Alfonso XIII. Upon stopping the multicab, they immediately conducted verification and learned that the lumbers is not covered by a transport permit. Due to lack of permit presented by the respondents, they declared arrest and apprehension. They brought the suspect together with the apprehended items at PNP Quezon Station for further investigation and proper disposition.

II. PRESENTATION OF PARTIES INVOLVED (Apprehending Officers and Respondents):

1. During the hearing, the apprehending officers were not present but they were able to submit their "Malayang Sinumpaang Salaysay". Based on the malayang sinumpaang salaysay of PSSg Donato B. Abog, on the evening of August 2, 2022, he and PLT John Rhain P. Baza were conducting patrolling using their patrol car. At around 11:50 PM along the national highway at Sitio Underground 1, Bgy. Alfonso XIII, Quezon, they noticed a multicab loaded with lumbers. They stopped the multicab and conducted verification and investigation.

During on-site investigation, the suspects were not able to present any legal documents to justify their possession and transport of lumbers. Immediately, they inform the suspects of their violation and their constitutional rights under Miranda Doctrine.

Subsequently, they declared arrest and apprehension, they brought the suspects and the apprehended items at PNP Quezon Station for further investigation and proper disposition.

2. In the same hearing Mr. Bernie Escovidal Masucol (driver) disclosed ownership of the multicab and Gmelina lumbers. He presented a transport permit but upon verification, it was determined that the permit was already consumed/used. Mr. Bernie explained that the lumbers were from Bgy. Tagusao, Quezon, Palawan and wanted to bring it at Brgy. Alfonso XIII, Quezon, Palawan as said lumbers are intended for the construction of their church.

III. APPLICABLE LAWS AND POLICIES:

- 1. Section 77 of PD 705 as amended or Revised Forestry Code of the Philippines "Cutting, Gathering and/or collecting Timber or other Forest Products Without License- any person who shall cut, gather, collect, remove timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code; Provided, that in the case of partnerships, associations, or corporations, the officers who ordered the cutting, gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.
- 2. Department Administrative Order No. 97-32 dated 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances used in the commission of crimes.

IV. FINDINGS/EVALUATION

- 1. The transport and possession of forest products (259.83 board feet of Gmelina lumbers) is not covered by appropriate DENR documents/permit, hence a patent violation of Section 77 of PD 705 as further amended.
- In view of the above statements and facts presented, it was found that there were sufficient and convincing evidences to support the finding of probable cause to charge Mr. Bernie Escovidal Masucol and Mr. Ronnie Escovidal Masucol for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.
- 3. Mr. **Bernie Escovidal Masucol** who is the driver is also the owner of the multicab and Gmelina lumbers.

V. RECOMMMENDATION

1. In view of the above findings and evaluation, it is recommended that 259.83 board feet board feet of Gmelina lumbers and one (1) unit of multicab bearing Plate Number FER 447 be confiscated in favor of the government in addition to the filling of case against the above —mentioned offender for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

Alfonso XIII, Quezon, Palawan, and RONIE MASUCOL y ESCOVIDAL, 19 y/o, born on October 29, 2002 at Tatay, Palawan, single, student and resident of Purok, Palmera, Brgy. Alfonso XIII, Quezon, Palawan.

5. How/Why: On August 2, 2022, at about 11:50 PM, PLT JOHN RHAIN P. BAZA, DCOP and PSSg Donato B Abog together with the two personnel from 1st PMFC, while conducting preventive patrol, noticed one Multicab powered by DIEHARDSHO named "RHEDICK" color blue, bearing plate no.
