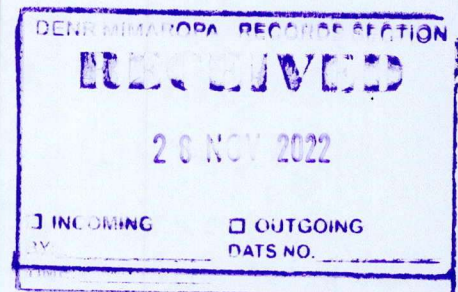

MOTION TO REVIVE CASE

PLAINTIFF REPUBLIC OF THE PHILIPPINES,
represented by the **DEPARTMENT OF ENVIRONMENT
AND NATURAL RESOURCES (DENR) Region IV-B
(MIMAROPA),** through the Office of the Solicitor General
(OSG) and unto this Honorable Court, respectfully states:

1. Per this Honorable Court's Order dated December 16, 2004,¹ the instant case was sent to the archives without prejudice to its revival on the ground that summons has not been served to the defendants for an unreasonable length of time because no transportation fees, facilities or sheriff's fees were provided by plaintiff to effect personal service of summons.

2. On December 20, 2019, the OSG sent to the DENR Region IV-B a Letter dated December 20, 2019² inquiring whether it is still interested in pursuing the case.

3. Consequently, on November 11, 2022, the OSG received the DENR Region IV-B's Letter Reply dated October 7, 2022³ stating its interest in reviving the case and its willingness to provide the necessary arrangements to address the lack of transportation provisions to personally serve the summons to the defendants.

4. In view thereof, plaintiff hereby respectfully moves for the revival of the case with an undertaking to coordinate with the Court's Sheriff for the personal service of summons.

5. The instant Motion is not intended to delay the disposition of this case, much less trifle with the generosity and magnanimity of this Honorable Court.

PRAYER

WHEREFORE, premises considered, it is respectfully prayed of this Honorable Court that the instant case **BE REVIVED**.

Other forms of relief just and equitable under the premises are likewise prayed for.

ORDER

The record of this case shows that the summons has not been served to the defendants for an unreasonable length of time for reasons that no transportation fees are provided for the Sheriff as this Office has no appropriations for this purpose, and considering further the fact that despite coordination and follow-up with the DENR for provision for proper service of summons yet said office is unable to provide transportation facilities or expenses for personal service of summons nor sheriff's fees as the distance involves more than 100 kilometers from Puerto Princesa City to the municipality where the defendants reside, thus, it is burdensome on the part of the Court Sheriff, and

In view of the foregoing, let the record of the case be sent to the ARCHIVES without prejudice to its revival in order that the case may not appear pending for indefinite period of time.


