Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated November 03, 2022 relative the above subject.

Per memorandum, the apprehension was made on September 22, 2022 at around 12:05 P.M. by the MES personnel of DENR CENRO Quezon and PNP Quezon Personnel. The team proceeded to the subject area and verified the report of the informant that there are cuttings of Acacia Mangium trees sliced into lumbers outside the approved area covered with Certificate of Tree Plantation Ownership (CTPO). Subsequently, the team discovered several piled of assorted sizes of lumbers of Acacia Mangium trees at Sitio Balintang, Barangay Isugod, Quezon, Palawan.

Based on field investigation, no person/claimant found in the area, hence, declared abandoned. The team apprehended the abandoned fifty (50) pieces lumbers of Acacia Mangium species having a total volume of 1,331.65 board feet with estimated fair market value of Php39,949.50.

The subject lumbers were hauled to DENR CENRO Quezon Compound, Quezon, Palawan under the custody of Forest Technician II Armando J. Batayo for safekeeping purposes.

Notices to the public dated October 3, 2022, October 12, 2022 and October 20, 2022 were posted on three (3) different conspicuous places in the municipality of Quezon, Palawan in relation to Section 8, Item No. 3 of DAO 1997-32. However, no one appeared and claimed in the Office. Hence, the absence of the owner/claimants to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with the CENRO recommendation for the issuance of confiscation order and order of finality of the apprehended item in favor of the government.



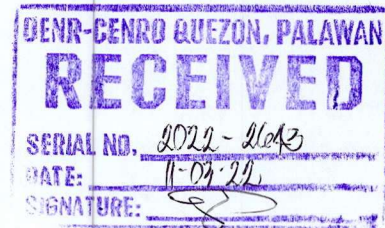

SUBJECT : **APPREHENSION AND SIEZURE OF FIFTY (50) PIECES OF ACACIA MANGIUM LUMBERS HAVING A TOTAL VOLUME OF 1,331.65 BOARD FEET AT SITIO BALINTANG, BRGY ISUGOD, QUEZON, PALAWAN**



Submitted herewith is the summary of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF CASE

WHAT : Apprehension of Fifty (50) pieces of Acacia Mangium lumbers having a total volume of 1,331.65 board feet with an estimated fair market value of Php 39,949.50.

WHEN : On or about 12:05 PM of September 22, 2022

WHO : No claimant/Abandoned

WHERE : Sitio Balintang, Brgy Isugod, Quezon, Palawan

HOW : Early in the morning of September 22, 2022, the DENR team was informed by the PNP Quezon personnel that there are undocumented lumbers piled at Sitio Balintang, Barangay Isugod, Quezon, Palawan. According to their informant, the said lumbers were cut/gathered outside the approved CTPO. To verify the report, Monitoring and Enforcement Section together with PNP Quezon proceeded to the said area and they apprehended 50 pieces of Acacia Mangium lumbers having a total volume of 1,331.65 board feet. Per on-site investigation, the team failed to gather any information regarding the ownership of the said forest products. Hence, it was declared as abandoned. The apprehended lumbers were brought to DENR-CENRO Quezon compound, Quezon, Palawan for safekeeping under the custody of FT. II Armando J. Batayo. Subsequently, a Seizure Receipt and Seizure Order dated October 04, 2022 were issued by the undersigned.

II. NOTICE TO THE PUBLIC FOR THE CONDUCT OF HEARING:

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, item No. 03, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks at the different conspicuous place of Quezon, Palawan was conducted by this Office.

III. FINDINGS/EVALUATION:

In spite of the three (3) consecutive notices posted however, no claimant appeared before this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.

IV. APPLICABLE LAWS:

Department Administrative Order No. 97-32 Section 8, item no. 3, Notice of Hearing shall be posted at least three (3) times, once every week for three (3) consecutive weeks, in at least three (3) public places, including, but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

V. RECOMMENDATION

In view hereof, it is recommended that the Fifty (50) pieces of Acacia Mangium lumbers having total volume of 1,331.65 board feet with an estimated market value of Php 39,949.50 apprehended at Sitio Balintang, Brgy Isugod, Quezon, Palawan be confiscated in favor of the government.
