SUBMISSION OF ADMINISTRATIVE HEARING REPORT RE: APPREHENDED ONE (1) UNIT RUSI TOPDOWN/MOTORCYCLE WITHOUT PLATE NUMBER LOADED WITH EIGHT (8) PIECES LUMBER WITH TOTAL VOLUME OF 84 BOARD FEET AT BARANGAY SUMBILING, BATARAZA, PALAWAN (E-FMS No. 2021-

175306-F61)

Respectfully forwarded is the memorandum of CENRO Brooke's Point, Palawan dated November 02, 2022 relative the above subject.

Per memorandum, the apprehension was made on November 01, 2021 at around 12:20 A.M. while the team spotted the suspicious motorcycle/topdown during the conduct of operation by the 2nd SOU, PNP MG, Balabac/Rio Tuba Detachment in response to the information relayed by an informant concerning the alleged violation of Section 77 of PD 705 at Barangay Sumbiling, Bataraza, Palawan.

The team intercepted/apprehended the one (1) unit Motorcycle (RUSI blue in color without plate number) with sidecar (topdwon) loaded with eight (8) pieces of Amugis and Marapisa lumbers having a total volume of 84 board feet without the required transport permit and other documentations. The apprehended items were recovered in the possession and control of Mr. Totoh G. Sable (owner/driver), a resident of Barangay Sumbiling, Bataraza, Palawan with participation of Janny Lito "Gagay" Bartolome.

The estimated fair market value of the Conveyance is Php21,000.00 while the lumber is Php4,200.00. The apprehended items are temporarily deposited/stockpiled at 2nd SOU, PNP MG, Balabac/Rio Tuba compound under the custody of PMsg Rudy C. Azares for safekeeping purposes.

Notices of hearings dated December 13, 2021, April 27, 2022, were sent to all concerned parties and the administrative hearings were conducted on December 21, 2021, January 17, 2022 and May 30, 2022 at the Office of CENRO Brooke's Point, M. Rodriguez St. Poblacion District I, Brooke's Point, Palawan in relation to Item No. 1 & 2, Section 7 of DAO 1997-32.

We concur with CENRO recommendation for the issuance of confiscation order for the apprehended forest product in favor of the government in addition to the filing of appropriate charges in court for violation of Section 77 of PD 705, as amended. As of this date, no other documents submitted to CENR office for the request of temporary release of conveyance.

II. STATEMENTS OF PARTIES INVOLVED DURING THE HEARING PROCESS

During the hearing, the apprehending officers did not attend of unknown reason despite notice sent to them. However, they sent their representative in the name of Moh. Imbran A. Balun. The hearing officer read the submitted Sworn Statement of Patrolman Keneth John Barrientos that on November 1, 2021, at 12:30 in the morning one (1) person was apprehended due to transporting of illegal cut of forest trees. According to them, that on October 31, 2021 at around 6:00 in the evening the team received information from the trusted informant about the illegal and chronic hauling of forest trees within the area of jurisdiction of Barangay Sumbiling, Bataraza, Palawan. After receiving the said information, PNCOIC PEMS Rodriguez immediately formed a group and designated PMsg Rudy Azares as team leader together with Patrolman L'vern C. Garzon to perform the said operation and to address the complaint. Also stated that on October 31, 2021 at 8:30 in the evening, the team left the station using motorcycles and proceeded to the subject barangay. At around 10: 30 in the evening, the team reached the subject barangay where there is chronic hauling of forest trees without permit. For the meantime, the team stopped to take a look around. Meanwhile, around 12:20 midnight of November 1, 2021, the team spotted a suspicious motorcycle not far from thier location that matched the information received by the team leader Rudy Azarez. The team approached and immediately instructed to stop the driver of the motorcycle (topdown) and conduct inspection/investigation after introducing that they are the members of 2ND SOU-MG assigned in Rio Tuba. The driver of the motorcycle (topdown), in the name of Totoh Sable, had immediately stopped. The Team leader, PMsg Rudy Azares, asked him if he has corresponding permit from the DENR about the lumber he was carrying, but he answered "no." Upon verifying, that on around 12:30 of the same day, PMsg Rudy Azares immediately declared apprehension and arresting him for violating the environmental law or Presidential Decree No. 705 or Forestry Code of the Philippines and instructed Patrolman La'vern C. Garzon to explain to him his rights of being arrested (Miranda Doctrine) in language that he understand in tagalog at the same time taking picture or photographs to be used as evidence in filing a case against the perpetrator/arrested. Also stated, that their team leader immediately informed PNCOIC PEMS Richard Rodriguez regarding the arrest and instructed to bring him to the headquarters for further documentation and appropriate filing of case. Meanwhile, the statement of Patrolman Keneth John Barrientos of 2nd SOU-MG Rio Tuba Detachment based on his Sword Affidavit was corroborated with the statement of PMSg Rudy Azares.

In the same hearing, Forest Technician II Abraham B. Vicente 38 years old and assign at CENRO-Rio Tuba Monitoring Station narrated that he received a referral instructing their team to conduct inspection and scaling on the forest products apprehended by 2nd SOU-MG at So. Marabahay, Barangay Rio Tuba, Bataraza, Palawan last November 1, 2021. Result disclosed that there are eight (8) pieces of assorted lumbers such as Amugis and Marapisa with an equivalent total volume of eighty-four (84) board feet. While the conveyance used was identified as Rusi motorcycle with side car (topdown) without plate number color blue. The subject forest product as well as the conveyance was deposited in the above mentioned detachment for safekeeping purposes.

For his part, Mr. Totoh G. Sable, a farmer, 35 years old and a resident of Barangay Sumbiling, Bataraza, Palawan averred during the hearing that on November 1, 2021, he was arrested because of transporting lumber from the command of a certain name Gagay Bartolome who also pointed out the location of the lumber near the river of Sumbiling. He also mentioned that he doesn't know what kind of lumber he was hauling. According to him, he has a debt (3 gantang of rice) to a certain Gagay Bartolome. In exchange for his debt, he shall haul the lumber from its location to Gagay's house. He further narrated that he hauled the lumber that evening since it was also the day that they agreed to be able to pay his debt.

He also admitted that he is the owner of the motorcycle (topdown) however, he has not presented any legal document pertaining to the motorcycle because it was left in his house. According to him, the subject motorcycle was being paid through installment basis. He was alone when he was caught and apprehended while on hauling operation and as far as he knew, the owner of the lumber has already coordinated with the barangay officials. In addition, they went to the house of the alleged owner of the lumber but he did not show or talked to him. According to him, he doesn't know that it was illegal to transport/haul the lumbers without permit.

Another hearing was schedule on January 4, 2022 inviting Mr. Janny Lito Bartolome to appear before this office for an opportunity to be heard and present evidence regarding the matter.

For his part, Mr. Janny Lito "Gagay" Bartolome is a farmer, a resident of Barangay Sumbiling, Bataraza, Palawan, born on April 6, 1973. According to him, he knew about Mr. Sable for a very long time that live in Sitio Makulango part of Barangay Taratak. During that day when he went to his field in Sitio Makulango, he met a man he never knew even his name, who offered him a lumber. He will tell him its location if he agreed to buy it at a very low price amounting to Php 1300. Interested to have it for making their table and for their vegetable shelves in their store, they proceeded to the location of the lumber in order for him to see it. The person went with him to Sumbiling to get the payment for the lumber.

Thinking on how to get the lumber, he thought of Toto Sable who barrowed him a 3 gantang of rice who also owned a topdown. For an exchange, he said to Toto Sable, to transport the lumber to his house. As to their agreement, Toto Sable shall deliver the lumber at night. But, he wondered why Toto Sable didn't deliver the lumber until the next morning. Further, he denied that he doesn't know the person who sold him the said lumber since what he wanted is the lumber that can be made for a table and shelf for vegetables. He also stated that he doesn't know what kind of lumber it is but it cost only of Php1,300. The said lumber was not delivered to his home since without knowing that it was already apprehended at the bridged. He also did not ask the person about the permit of the lumber since all he wanted was to have it, that's all he thought.

Another hearing was schedule on May 30, 2022 inviting Mrs. Mary Jane Sable, owner of the apprehended conveyance to appear before this office for an opportunity to be heard and present evidence regarding the matter.

During the hearing, Mrs. Mary Jane Sable stated that she does not completely understand the content of the Affidavit of Undertaking subscribed by a lawyer that she had submitted to this Office, thus the hearing officer explained the content of which to Mrs. Sable. Also in the hearing, Mrs. Sable claimed that she has no prior knowledge or any participation regarding the transaction/agreement between her husband, Mr. Totoh Sable and Mr. Janny Lito "Gagay" Bartolome. She also mentioned that they usually utilize the conveyance for hauling/loading of rice grains and copra. Mrs. Sable added that the registration of the subject conveyance has not been released as she only assumed the payment for the balance of the motorcycle from someone else.

III. FINDINGS/EVALUATION

The possession and transport of forest products are not covered by appropriate DENR documents or permits hence a patent violation of Section 77 of PD 705 as further amended.

In view of the facts presented, it was determine and found out that there are sufficient and convincing evidences to support the finding of probable cause to charge MR. TOTOH G. SABLE and JANNY LITO BARTOLOME of violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

On the other hand, after a careful evaluation of the case, it was determined that Mrs. Mary Jane Sable has no direct participation nor knowledge and consent on the transaction made by Mr. Totoh Sable and Mr. Janny Lito Bartolome. Mrs. Sable expressed intent to request for the temporary release of the one (1) unit Rusu motorcycle (Topdown) by submitting an affidavit of undertaking however to date aside from said document this Office have not received any other required documents requesting for the release of the subject conveyance.

IV. RECOMMMENDATION

In view of the above findings and evaluation of the instant case, it is recommended that the apprehended forest products be confiscated in favor of the government in addition to the filing of appropriate charges in court against the above mentioned offender for violation of Sec. 77 of PD 705 as further amended by EO 277 and RA 7161.

Moreover, it is informed that the owner of one (1) unit Rusi motorcycle (Topdown), Mrs. Mary Jane Sable has no direct participation, connection and knowledge in the loading and transport of lumbers using the Rusi motorcycle (Topdown) and expressed intent to request for the temporary release of the conveyance, however as of to date, no other required documents aside from the Affidavit of Undertaking was received by this Office.
