- a. The subject lots are within Alienable and Disposable Land per Land Classification Map No. 2182, Project 14-B, Block XIII, approved on March 21, 1958 while portion of Lot 356 is within Alienable and Disposable Land per Land Classification Map No. 2808, Project 14-C, Block III dated October 13, 1981.
- b. The subject lot was plotted and evaluated based on the attached V-37 by the Office of the CENRO.
