Dear Sir,

Furnishing you a copy of Decision, Motion for Reconsideration, Resolution and Reporting for Duty and I hope no one like me will be sued and suspended.

The case of Castor Rey Rojas versus People of the Philippines had pursuant to First Paragraph of Section 80 PD 705 as amended by PD 1775 re numbered by RA 7161 now Section 89 of PD 705, pursuant to section 1 of EO 277 and pursuant to section 68 now section 77 of PD 705 (*"The court shall further order the confiscation in favor of the government of the timber or any forest products cut, gathered, collected, removed or possessed as well as the machinery, equipment, implements and tools illegally used in the area where the timber or forest products are found"*).

The case of DENR versus Gregorio Daraman et al. G.R. No. 125797 had pursuant to Second Paragraph of Section 80 of PD 705 as amended by PD 1775 re numbered by RA 7161 now Section 89 of PD 705 (DAO No. 97-32), pursuant to section 2 of EO 277 and pursuant to Section 77-A (*"Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation"*).

I hope that there will be an EO for the reconciliation of the Court and DENR. *h*


