




As to no avail, the barangay officials were apprehensive to be one of the witness since they endorse the said project for the betterment of said Barangay.

**A RESOLUTION THAT THE BARANGAY GOVERNMENT OF BINTUAN HAS NO OBJECTION FOR THE CONSTRUCTION OF CORON-CULION INTER-ISLAND BRIDGE TRAVERSE FROM BARANGAY BINTUAN TO BARANGAY JARDIN, CULION, PALAWAN**

**WHEREAS**, RA 7160 otherwise known as the Local Government Code of 1991 SEC. 17 Basic Services and Facilities. (3) For a Province. (vii) Infrastructure facilities intended to service the need of the residents of the province and which are funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal water-works, drainage and sewerage, flood control, and irrigation systems; reclamation projects; and similar facilities;

**WHEREAS**, the Provincial Government of Palawan thru Department of Public Works and Highways (DPWH) proposed the construction of Coron-Culion Bridge funded under General Appropriations Act (GAA), which will start at Barangay Bintuan;

**WHEREAS**, based on the approved plan submitted in the office of the barangay, the widening of road will start from Sitio Cayancanan going to Sitio Ineltek of this barangay;



WHEREAS, a mandatory public consultation thru barangay assembly was set and conducted by the barangay Council, participated by DPWH, the contractor, and the residents which will be affected by the opening of road;

WHEREAS, the proposed construction of Coron-Culion bridge would open more economic opportunities, increase access to social services and boost the development of the municipal and the entire province of Palawan;

WHEREAS, the Sangguniang Barangay of Bintuan recommends to take measures towards environmental protection thru replacing of affected cut trees by planting seedlings after the opening of road is carried out;


NOW THEREFORE, on motion of Hon. Lury O. Austria, duly seconded by Hon. Arnel A. Abeleda, be it;




