MEMORANDUM OF AGREEMENT

KNOW ALL PEOPLE BY THESE PRESENTS:

This agreement entered into by and between:

The Community Environment and Natural Resources Office, Department of Environment and Natural Resources MIMAROPA Region with Office address at Barangay III, Roxas, Palawan, herein represented by the **CENRO PABLO L. CRUZ** hereinafter referred as DENR;

The Local Government of Barangay Mendoza, Roxas, Palawan, herein represented by Punong Barangay, **ERNESTO S. LLANERA JR.**, hereinafter referred to as **BARANGAY LGU**.

WITNESSETH: That,

WHEREAS, The DENR is mandated as the primary agency responsible for the protection of all natural resources including the Protected Areas pursuant to P.D. 705 – the Forestry Reform Code, as amended and P.D. 1067- the Water Code;

WHEREAS, the Local Government of Barangay San Nicolas, Roxas, Palawan who has jurisdiction over the area of Barangay Mendoza, Roxas, Palawan has passed a Resolution No. 13, Series of 2022, Entitled “**RESOLUTION ADOPTING FOREST PROTECTION AND ANTI-ILLEGAL LOGGING WITHIN THE JURISDICTION OF BARANGAY MENDOZA, ROXAS, PALAWAN**” dated July 13, 2022.

WHEREAS, the said resolution was passed by the LGU of Barangay Mendoza, Roxas, Palawan to enhance its campaign against rampant illegal activities in violation to environmental laws such as but not limited to P.D. 705, as amended, and P.D. 1067.

WHEREAS, the LGU concerned has committed their full support and initiative for the effective implementation of environmental laws, rules and regulations in order to stop the illegal activities within their administrative of jurisdiction (RA7160); and

WHEREAS, the parties are committed to work hand in hand for the protection of our natural resources with strong participation of all stakeholders.

NOW THEREFORE, for and in consideration of the foregoing premises and of the mutual covenants hereinafter set forth, the parties of (DENR-CENRO ROXAS, PALAWAN and LGU-BARANGAY MENDOZA) as they hereby agreed, to the following arrangements and provisions for the effective implementation of environmental laws, rules and regulations;

I. ROLES AND RESPONSIBILITIES OF THE PARTIES

1. The DENR shall: (Duties and responsibilities)

- 1.1 Assist and extend all technical assistance with regards to enforcement of all environmental laws, rules and regulations;
- 1.2 Lead the conduct of regular patrolling and surveillance activities;



- 1.3 Conduct seminar on capacity building regarding environmental aspects for Barangay Officials and recommend issuance of deputation order as Wildlife Enforcement Officer (WEO) and Deputized Environment and Natural Resources Officer (DENRO);
- 1.4 Attend Barangay Assembly meeting whenever invitation received;
- 1.5 Provide all needed documents appertaining to natural resources issues requested by the Barangay as the law may allow;
- 1.6 Always coordinate with said Barangay whenever an activity is within its jurisdiction as consequences/situation may allow.

2. The Barangay Mendoza shall: (Duties and responsibilities)

- 2.1 Assist the DENR in the conduct of regular patrolling and surveillance activities in the area;
- 2.2 Report immediately to the DENR regarding illegal activities within the barangay such as kaingin, squatting and establishment of infrastructure within foreshore areas, salvage zones, buffer zones and forestlands, tree cutting, use of chainsaw without registration, wood charcoal making, wildlife hunting and trade, gathering of minor forest products, mining/quarrying, etc.;
- 2.3 Provide assistance in the conduct of Information and Education Campaign (IEC);
- 2.4 Issue barangay clearance in consonance with the Local Government Code of the Philippines and upon request of DENR;
- 2.5 Be responsible in the prohibition of all acts in violation of the Local Government Code, P.D. 705 as amended and all existing environmental laws and policies of the country;
- 2.6 Assist the DENR in the investigation of cases for filing of criminal information in proper Court of law against environmental laws violators within its area of jurisdiction, if necessary, with respect to the discretion of the Punong Barangay;
- 2.7 Maintain an Official Book/Record folder for all environmental reports, documents and other supplemental information and references.

This agreement entered into by and between:

The Community Environment and Natural Resources Office, Department of Environment and Natural Resources MIMAROPA Region with Office address at Barangay III, Roxas, Palawan, herein represented by the **CENRO PABLO L. CRUZ** hereinafter referred as DENR;

The Local Government of Barangay San Nicolas, Roxas, Palawan, herein represented by Punong Barangay, **ESTARNILO A. PACTAO**, hereinafter referred to as **BARANGAY LGU**.

WITNESSETH: That,

WHEREAS, The DENR is mandated as the primary agency responsible for the protection of all natural resources including the Protected Areas pursuant to P.D. 705 – the Forestry Reform Code, as amended and P.D. 1067- the Water Code;

WHEREAS, the Local Government of Barangay San Nicolas, Roxas, Palawan who has jurisdiction over the area of Barangay San Nicolas, Roxas, Palawan has passed a Resolution No. 05, Series of 2022, Entitled **“RESOLUTION ADOPTING FOREST PROTECTION AND ANTI-ILLEGAL LOGGING WITHIN THE JURISDICTION OF BARANGAY SAN NICOLAS, ROXAS, PALAWAN”** dated June 8, 2022.

WHEREAS, the said resolution was passed by the LGU of Barangay San Nicolas, Roxas, Palawan to enhance its campaign against rampant illegal activities in violation to environmental laws such as but not limited to P.D. 705, as amended, and P.D. 1067.

WHEREAS, the LGU concerned has committed their full support and initiative for the effective implementation of environmental laws, rules and regulations in order to stop the illegal activities within their administrative of jurisdiction (RA7160); and

WHEREAS, the parties are committed to work hand in hand for the protection of our natural resources with strong participation of all stakeholders.

NOW THEREFORE, for and in consideration of the foregoing premises and of the mutual covenants hereinafter set forth, the parties of (DENR-CENRO ROXAS, PALAWAN and LGU-BARANGAY SAN NICOLAS) as they hereby agreed, to the following arrangements and provisions for the effective implementation of environmental laws, rules and regulations;

I. ROLES AND RESPONSIBILITIES OF THE PARTIES

1. The DENR shall: (Duties and responsibilities)

- 1.1 Assist and extend all technical assistance with regards to enforcement of all environmental laws, rules and regulations;
 - 1.2 Lead the conduct of regular patrolling and surveillance activities;

- 1.3 Conduct seminar on capacity building regarding environmental aspects for Barangay Officials and recommend issuance of deputation order as Wildlife Enforcement Officer (WEO) and Deputized Environment and Natural Resources Officer (DENRO);
- 1.4 Attend Barangay Assembly meeting whenever invitation received;
- 1.5 Provide all needed documents appertaining to natural resources issues requested by the Barangay as the law may allow;
- 1.6 Always coordinate with said Barangay whenever an activity is within its jurisdiction as consequences/situation may allow.

2. The Barangay San Nicolas shall: (Duties and responsibilities)

- 2.1 Assist the DENR in the conduct of regular patrolling and surveillance activities in the area;
- 2.2 Report immediately to the DENR regarding illegal activities within the barangay such as kaingin, squatting and establishment of infrastructure within foreshore areas, salvage zones, buffer zones and forestlands, tree cutting, use of chainsaw without registration, wood charcoal making, wildlife hunting and trade, gathering of minor forest products, mining/quarrying, etc.;
- 2.3 Provide assistance in the conduct of Information and Education Campaign (IEC);
- 2.4 Issue barangay clearance in consonance with the Local Government Code of the Philippines and upon request of DENR;
- 2.5 Be responsible in the prohibition of all acts in violation of the Local Government Code, P.D. 705 as amended and all existing environmental laws and policies of the country;
- 2.6 Assist the DENR in the investigation of cases for filing of criminal information in proper Court of law against environmental laws violators within its area of jurisdiction, if necessary, with respect to the discretion of the Punong Barangay;
- 2.7 Maintain an Official Book/Record folder for all environmental reports, documents and other supplemental information and references.


