NARRATIVE

DENR is the primary agency assigned to protect the Countries Environment and Natural resources. Wildlife Transport Monitoring is one of the Activity perform by the Enforcement and Monitoring Section (EMS) of DENR-CENRO Sablayan, and were conducted regularly covering Sablayan and all the areas of MAPSA Municipalities.

On October 4, 2022, the Civil Aviation Authority of the Philippines, Mamburao Airport located at Barangay Payompon, Mamburao, Occidental Mindoro were monitored by selected Enforcement and Monitoring Section (EMS) personnel of DENR-CENRO Sablayan. No illegal activity found after 24 hours of monitoring activity.

Selected EMS personnel were deployed and monitored the sea port of Sablayan, located at Barangay Poblacion of the said Municipality on October 13, 2022. Every suspected vehicle and vessel was inspected. After 24 hours of duty, there were no illegal activity encountered during the monitoring.

Monitoring activity at port of Abra de Ilog located at Sitio Matabang, Barangay Urilan of the said Municipality was conducted on October 18, 2022. All vehicles on the port are searched and checked well by selected Enforcement and Monitoring Section (EMS) personnel during the activity. After 24 hours of duty and monitoring, illegal forest activity is not observed.
