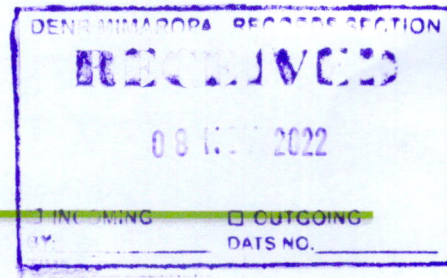

RESOLUTION NO. 24
Series of 2022

WHEREAS, the Department of Environment and Natural Resources (DENR) issued DENR Administrative Order No. 2020-12 with the subject of Rationalizing Dredging Activities in Heavily-Silted River Channels within the Province of Occidental Mindoro pursuant to the DENR-DPWH-DILG-DOTC Joint Memorandum Circular No. 1 Series of 2019;

WHEREAS, Section 2 (c) Title VII of the above-mentioned Administrative Order states that *"The inter-agency committee shall have the following powers and functions: b. Shall propose policies and programs to rationalize the dredging operations."*

WHEREAS, to provide immediate and adequate assistance to our countrymen affected by floods due to the heavily-silted river systems in the Province of Occidental Mindoro, it becomes imperative for this Body to issue resolutions that will create an operating structure for dredging operations in said province;

WHEREAS, R.V Laborte Builders is one of the qualified proponents to undertake river restoration activities on the heavily-silted rivers of Occidental Mindoro for having complied with the financial and technical requirements set by the Inter-Agency Committee on the Restoration of Occidental Mindoro Rivers and its Tributaries;

WHEREAS, in a letter dated October 11, 2022, R.V. Laborte Builders, through its Owner/ Manager Reynaldo V. Laborte Jr., requested the Inter-Agency Committee to be allowed to conduct an Environmental Impact Assessment (EIA) Test on the river delta of Tubili River to determine the adverse effects, if any, of its project on the environment and determine the possible actions to avoid, reduce or mitigate such effects at the earliest possible time;

WHEREAS, Governor Eduardo B. Gadiano, Chairman of the IAC, endorsed the said request of R.V. Laborte Builders to the Inter-Agency Committee for appropriate action, through an endorsement letter dated October 17, 2022;

NOW THEREFORE, by unanimous decision of all the members, **BE IT RESOLVED**, as this Body hereby resolves *"to allow and authorize R.V. Laborte Builders to conduct Environmental Impact Assessment (EIA) Test on the river delta of Tubili River subject to prior coordination with the DENR, the municipal and barangay officials having jurisdiction over Tubili River, the Philippine Coast Guard and the Philippine Ports Authority."*
