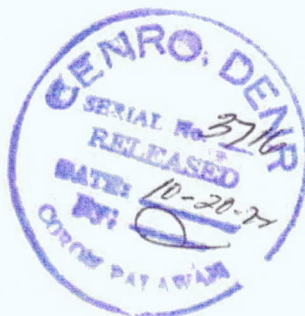

ANNUAL NATIONAL CONFERENCE**


