

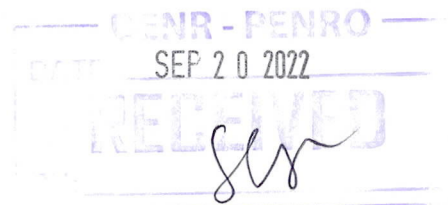

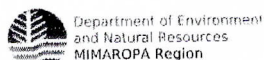

ORDER

Records show that on November 5, 2021 at around 5:00 pm, at Sitio Can Ayong, Barangay Marigondon Sur, San Andres, Romblon, the personnel of Enforcement and Monitoring Section of PENRO-Romblon and elements of San Andres Municipal Police Station apprehended ten (10) pieces of lumber of Narra species having an aggregate volume of 0.25 cubic meter (107.3 board feet), with an estimated fair market value of PHP 21,460.00. The subject forest products has no claimant/s during the time of apprehension and were hauled and deposited at the DENR-PENRO Romblon compound for safekeeping. A Seizure Order and Seizure Receipt, both dated November 05, 2021 were issued by PENRO Maximo C. Landrito, Seizure Officer.

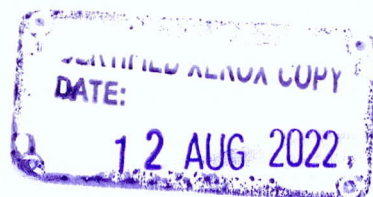
Pursuant to **Section 8 of DAO 97-32**, the PENRO concerned posted Notices of Hearing on *November 22, 2021, November 29, 2021 and December 06, 2021*, in conspicuous public places within the locality, informing the claimant/s to appear and show cause why the apprehended items should not be confiscated in favor of the government. However, despite said notices no one came to claim ownership of the same, hence considered **"ABANDONED."**

WHEREFORE, PREMISES CONSIDERED, the ten (10) pieces of lumber of Narra species having an aggregate volume of 0.25 cubic meter (107.3 board feet), with an estimated fair market value of PHP 21,460.00 apprehended at Sitio Can Ayong, Barangay Marigondon Sur, San Andres, Romblon, are hereby **CONFISCATED** in favor of the government to be disposed of in accordance with existing DENR laws, rules and regulations governing the matter.

CERTIFICATION

This is to **CERTIFY** that per records on file in this Office, an **ORDER** dated AUG 12 2022 was issued in the above-captioned case confiscating the ten (10) pieces of lumber of Narra species having an aggregate volume of 0.25 cubic meter (107.3 board feet), apprehended at Sitio Can Ayong, Barangay Marigondon Sur, San Andres, Romblon.

In compliance with Section 8(3), DAO 97-32, three (3) Notices of Hearing dated *November 22, 2021, November 29, 2021 and December 6, 2021*, over the apprehended items were posted for three (3) consecutive weeks in three (3) conspicuous public places in the locality.

Since no owner, claimant, or other interested party appeared at the proceedings, such failure to appear is deemed as a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government, as provided under Section 8(3), DAO 97-32.

Moreover, under Section 7, DAO 97-32, a Decision/Order shall become final and executory upon the lapse of fifteen (15) regular business days unless a Motion for Reconsideration is filed. Hence, the said Order is declared **FINAL AND EXECUTORY**. The confiscated items are deemed permanent property of the Government and shall be entered into the books of the concerned PENRO to be disposed of in accordance with the applicable laws, rules and regulations.
