

CONFISCATION OF FORTY-TWO (42) PIECES OF LUMBER OF GMELINA SPECIES HAVING AN AGGREGATE VOLUME OF 0.91 CUBIC METER (385.16 BOARD FEET) APPREHENDED AT SITIO BALABAG UPPER, BARANGAY MATUTUNA, SAN ANDRES, ROMBLON

#### ORDER

Records show that on May 23, 2022 at around 7:00 in the eveñing, at Sitio Balabag Upper, Barangay Matutuna, San Andres, Romblon, the elements of San Andres Municipal Police Station and PENRO Romblon personnel apprehended forty-two (42) pieces of lumber of Gmelina species having an aggregate volume of 0.91 cubic meter (385.16 board feet), with an estimated fair market value of PHP 13,480.00. The subject forest products have no claimant/s during the time of apprehension and were hauled and deposited at the San Andres Municipal Police Station for safekeeping. A Seizure Order and Seizure Receipt, both dated May 23, 2022 were issued by Chief, Technical Services Division Thelmo S. Hernandez, Seizure Officer.

Pursuant to Section 8 of DAO 97-32, the PENRO concerned posted Notices of Hearing on May 30, 2022, June 06, 2022 and June 13, 2022, in conspicuous public places within the locality, informing the claimant/s to appear and show cause why the apprehended items should not be confiscated in favor of the government. However, despite said notices no one came to claim ownership of the same, hence considered "ABANDONED."

WHEREFORE, PREMISES CONSIDERED, the forty-two (42) pieces of lumber of Gmelina species having an aggregate volume of 0.91 cubic meter (385.16 board feet), with an estimated fair market value of PHP 13,480.00, apprehended at Sitio Balabag Upper, Barangay Matutuna, San Andres, Romblon, are hereby CONFISCATED in favor of the government to be disposed of in accordance with existing DENR laws, rules and regulations governing the matter.

The PENRO concerned is hereby directed to haul and deposit the apprehended forest products to PENR Office Rombion compound and take full custody thereof.

#### CERTIFICATION

This is to CERTIFY that per records on file in this Office, an ORDER dated was issued in the above-captioned case confiscating forty-two (42) pieces of lumber of Gmelina species having an aggregate volume of 0.91 cubic meter (385.16 board feet), with an estimated fair market value of PHP 13,480.00, apprehended at Sitio Balabag Upper, Barangay Matutuna, San Andres, Romblon.

In compliance with Section 8(3), DAO 97-32, three (3) Notices of Hearing dated *May 30*, 2022, *June 06*, 2022 and *June 13*, 2022, over the apprehended items were posted for three (3) consecutive weeks in three (3) conspicuous public places in the locality.

Since no owner, claimant, or other interested party appeared at the proceedings, such failure to appear is deemed as a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government, as provided under Section 8(3), DAO 97-32.

Moreover, under Section 7, DAO 97-32, a Decision/Order shall become final and executory upon the lapse of fifteen (15) regular business days unless a Motion for Reconsideration is filed. Hence, the said Order is declared **FINAL AND EXECUTORY**. The confiscated items are deemed permanent property of the Government and shall be entered into the books of the concerned PENRO to be disposed of in accordance with the applicable laws, rules and regulations.
