

(FORMERLY BANCORO), NAUJAN, ORIENTAL MINDORO

In connection to the above cited subject, please be informed that the undersigned conducted inventory of naturally grown narra trees within the titled property of Alleen Malapitan Pitalco located at Brgy. Laguna (Formerly Bancoro), Naujan, Oriental Mindoro.

The land owner is requested 21 narra trees to be cut within the titled property. Upon the ground verification, based on the findings the tree number 4,5,6 tree number 9, 10, 11,12,13,14,15,16,17,18,19,20,21 are within the steep slope and cliff of the mountain with more than 18% in slope. Hence, the undersigned recommends for selective cutting shall undertake on the area for the protection of soil erosion and other possible disaster might occurs.

The GIS Specialist plotted the Geo tag pictures of the said trees, tree number 1,2,3,7,8,10 are outside from the titled property of the proponent. As a result, only five (5) narra trees will recommend for tree cutting permit with an aggregate of volume of 7.13 cubic meters. The owner wants to cut those trees to sell and use the lumber for furniture's. Likewise, they want to replace some fruit bearing trees on the said area.

In this regard, the undersigned interposes no objection on the said request and recommends the issuance of cutting permit in accordance with the DENR laws, rules and regulations.
