

#### I. FACTUAL BACKGROUND

Illegal wildlife trade is considered as one of the main threats to wildlife resources, all over the world. This act have adverse effects to the ecological balance and probable extinction of some wildlife species.

A Wildlife Traffic Monitoring Unit was created to ensure the strict compliance and effective implementation of all existing wildlife laws, rules and regulations, including pertinent international agreements. The team have started monitoring in 2021 and continues to date.

Monitoring activities have also created a stronger partnership with the law both the Philippine National Police and the Philippine Coast Guard. They have been allies in the protection and conservation of the environment and have extended their aid to this office since the activity started, and on other activities involving guarding the environment from lawless citizens. A set of Wildlife Enforcement Officers (WEO) was issued with renewed deputation from the Regional Office in January 2022. These officers are currently helping in the conduct of monitoring in the province of Romblon.

#### II. LEGAL BASIS

REPUBLIC ACT NO. 9147 "Wildlife Resources Conservation and Protection Act."

 An act providing for the conservation and protection of wildlife resources and their habitats, appropriating funds therefor and for other purposes






