This is to forward the herewith letter dated 20 September 2022 from Director Cherry Pie Felisse M. Maraya, Office for Facilitation of Presidential Assistance, Office of the President, with Tracking ID No. PMS-202209-2321, referring the letter dated 12 September 2022 addressed to President Ferdinand Romualdez Marcos, Jr., of Ms. Maria Paz C.
