
**SUBJECT : SPOT REPORT RE: APPREHENDED ONE HUNDRED SEVENTEEN (117) PIECES LUMBER (BATINO SPECIES) WITH A TOTAL VOLUME OF 565 BOARD FEET AT BRGY. CHEEY, BUSUANGA, PALAWAN**

Respectfully forwarded the memorandum of CENRO Coron, Palawan dated September 19, 2022 relative the above subject.

Per spot report, the apprehension was made on September 18, 2022 at around 07:10 P.M. by the LAWIN Team/Quick Response Team (QRT), PNP Maritime Group (Coron-SOU II) and Busuanga MPS at Barangay Cheey, Busuanga, Palawan. The team apprehended one (1) unit Mitsubishi Canter Mini Dump Truck loaded with one hundred seventeen (117) pieces lumber of Batino (Kukulayan) species. The corresponding volume is 565 board feet without proper permit in violation of Section 77 of PD 705, as amended. The alleged perpetrators were identified and arrested as Punong Barangay Hon. Gemmuel n. Fabia (Driver) and Mr. Allan Alarcon (Helper).

The apprehended lumbers are subject for hauling for custody at CENR Office followed by administrative confiscation proceedings in accordance with DAO 1997-32.

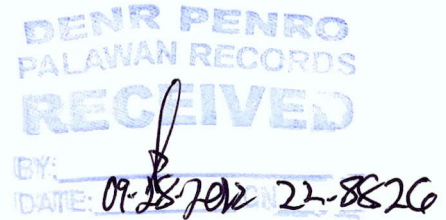

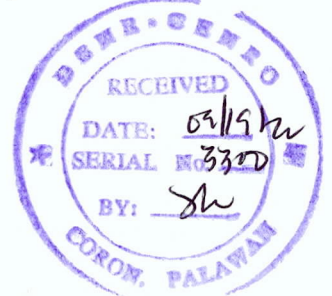
