
This pertains to the apprehended tricycle loaded with twenty (20) Philippine Duck by the elements of the Philippine National Police-Naujan Municipal Station (PNP–Naujan MPS) on 16 April 2022. Naujan MPS turned-over the following to CENRO Socorro: (a) one (1) unit of tricycle with Chassis No. BC175H-B32531; (b) seventeen (17) live Philippine Duck; and (c) three (3) dead Philippine Duck.

Unfortunately, there were two (2) additional casualties prior to the scheduled release of the remaining live ducks on April 18, 2022 at Naujan Lake National Park (NLNP) specifically at Barangay Bambanin, Victoria, Oriental, Mindoro – their natural habitat. In sum, five (5) dead ducks were buried in the backyard of CENRO Socorro while fifteen (15) live ducks were released in their natural habitat.

Three (3) suspects were arrested and charged for violation of Republic Act No. 9147, otherwise known as "Wildlife Resources Conservation and Protection Act".



Respectfully submitting the report on the release of 15 Philippine Ducks (*Anas luzonica*) in Barangay Bambanin, Victoria, Oriental Mindoro. The release was held on April 18, 2021. The Philippine ducks were apprehended from wildlife violators. These were turned-over to CENRO Socorro by PCPI Christopher S. Montiano and PSSg Anthony S. Jovanal of Municipal Police Station of Naujan.

Based on the report, a total of 20 live Philippine ducks and several implements were confiscated on April 16, 2022. The three (3) suspects were apprehended in Barangay Barcenaga, Naujan, Oriental Mindoro during the *Oplan Sita*. The filing of case against the suspects are on-going.

About 17 live and three (3) dead Philippine ducks were surrendered to this Office on April 17, 2022. The surviving ducks were not released yet because of the inclement climatic condition that might further stress the animals. The species were temporarily taken cared of by CENRO Socorro to allow the ducks to recover and increase their chance of survival.

Unfortunately, there were two (2) additional casualties on April 18, 2022. On the said date, the 15 remaining Philippine ducks were released back to NLNP specifically within the administrative jurisdiction of Barangay Bambanin, Victoria, Oriental Mindoro.



Respectfully submitting herewith the report on the release of 15 Philippine Ducks (*Anas luzonica*) in Barangay Bambanin, Victoria, Oriental Mindoro. The release was held on April 18, 2021. The Philippine ducks were apprehended from three (3) wildlife violators. These were turned-over to CENRO Socorro by PCPI Christopher S. Montiano and PSSg Anthony S. Jovanal of Municipal Police Station of Naujan.

On April 16, 2022 around 8:20 in the morning, the personnel of Municipal Police Station of Naujan is conducting an *Oplan Sita* in the Strong Republic Nautical Highway of Barangay Barcenaga, Naujan, Oriental Mindoro. The Kawasaki tricycle driven by Edilberto Fernandez Labay counter flowed to the traffic. The police personnel of the said station accosted the said tricycle driver at the juncture. It was found that the vehicle was loaded with 20 live Philippine ducks. The suspects were arrested and appraised immediately by the apprehending officers.


The arrested suspects were identified as Edilberto Fernandez Labay (driver), 57 years old, married, farmer, resident of Barangay Mahabang Parang, Naujan; Demetrio Atienza Andal, 60 years old, farmer, a resident of Barangay Sta. Maria, Naujan; and Victor Andal Panopio, 62 years old, married, jobless, a resident of Barangay Sta. Maria, Naujan, Oriental Mindoro.

The items confiscated from their possession include:

- 1. 20 live Philippine ducks (Anas luzonica);
- 2. Nine (9) pieces of bamboo sticks with strings;
- 3. Eight (8) pieces of rolled wire;
- 4. Four (4) pairs of bamboo sticks with nets;
- 5. One (1) piece bamboo stick;
- 6. One (1) piece shovel; and
- 7. One (1) unit Kawasaki tricycle with Chassis No. BC175H-B32531.

PCPI Montanio and PSSg Jovanal coordinated with CENRO Socorro and turned-over the apprehended wildlife on April 17, 2022. Necessary documents are being prepared for filing of case against the suspects.

Unfortunately, there were another two (2) casualties on April 18, 2022. On the said date, the 15 remaining Philippine ducks were released back to NLNP (specifically within the administrative jurisdiction of Barangay Bambanin, Victoria, Oriental Mindoro) – their natural habitat






Figure 1. Dead Philippine ducks buried in the backyard of the Office.


