JUDICIAL AFFIDAVIT

MACARIO, JR. V. TAJONERA, herein represented by counsel and to this Honorable Court, respectfully submits this Judicial Affidavit in compliance with A.M. No. 12-8-8-SC, and offers the following testimony:

1. To prove that he is one of the surviving heirs of Clenia V. Tajonera and is claiming for himself and for the benefit of co-heirs rights of ownership over portions of Lot 1305 and 1306, Pls-22 at Barangay San Vicente, Sta. Cruz, Occidental Mindoro.
2. Clenia V. Tajonera has been exercising rights of ownership and possession over two portions of land at Brgy. San Vicente, Sta. Cruz, Occidental Mindoro, one is identified as Lot 1306 (Part) Pls-22 with an area of two (2) hectares, and Lot 1305 (Part) Pls-22 with an area of 89,280 square meters. The property rights of Clenia V. Tajonera emanated from her successors-in-interest, Carlos Tria in Lot 1306 and Spouses Amador Catama Sr. and Francisca Abeleda Catama in Lot 1305.
3. Both properties are declared for tax purposes under the name of Clenia Tajonera, and being administered then by Manuel Tajonera as evidenced by Declarations of Real Property.
4. Since the acquisition of the property, Clenia V. Tajonera religiously paid for the real property taxes thereof and utilized and fenced the said properties in preparation of the intended development of subdivision.
5. Claimants-heirs of Clenia V. Tajonera oppose the claim of Luz Gutierrez, Gemma Teresa Simbahan, and Victor Gutierrez in Lot 1306-Part, and vehemently deny the alleged reconveyance of property made to Leticia Gutierrez.
6. To identify documents and testify on the contents thereof.
7. To testify on other matters which are material, relevant and incidental to this case.

I, **MACARIO, JR. V. TAJONERA**, Filipino, of legal age, married, and with address at Brgy. 5, Mamburao, Occidental Mindoro, fully conscious that I, before Atty. Kathrine Ann A. Abeleda in Mamburao, Occidental Mindoro, answer the following questions under oath, and that I may face criminal liability for false testimony or perjury, hereby depose and state:

1. **Q:** What language do you prefer in making this judicial affidavit?
A: Kahit po English ang tanong at Tagalog na lamang po ang aking sagot ma'am.

2. **Q:** Are you the same Macario V. Tajonera, Jr. who filed an Answer in the instant Cadastral Case?

A: Yes, ma'am, ako po kasama ang kapatid kong si Jose V. Tajonera, para sa aming mga naiwan ng Clenia V. Tajonera.

3. **Q:** If that Answer will be shown to you, will you be able to identify it?

A: Yes, ma'am.

4. **Q:** I am showing you this document entitled Answer, and which also forms part of the record of this case, is this the one you are referring to?

A: Yes, ma'am, ito po ang aking pirma.

Counsel: Your Honor, the witness pointed to his signature over the name Macario V. Tajonera, Jr. on the 4th page of the Answer. May we request that this Answer identified by the witness be marked as our **Exhibit "H"** and his signature as **Exhibit "H-1"**.

5. **Q:** What is your proof as to the death of Clenia V. Tajonera?

A: Ito po ma'am Death Certificate niya.

Counsel: Your Honor, the witness handed to this counsel a copy of the Certificate of Death of Clenia V. Tajonera which we request to be marked as our **Exhibit "I"**.

6. **Q:** What is your proof that you are one of the children of Clenia V. Tajonera?

A: Ang akin pong Birth Certificate ma'am, narito po.

Counsel: Your Honor, the witness handed to this counsel a copy of his Certificate of Birth which we request to be marked as our **Exhibit "J"**.

7. **Q:** What is the subject property of your claim in this cadastral proceeding?

A: Dalawa po ma'am. Una po ay ang 2 hectares sa Lot 1306, Pls-22 at ikalawa po ay ang parte ng 1305, Pls-22 na mayroong sukat na 89,280 square meters.

8. **Q:** What are the bases of your claim over the subject property?

A: Lahat po iyan ay nakarehistro sa pangalan ng aking nanay na si Clenia V. Tajonera sa deklarasyon ng lupa sa Municipal Assessor's Office ng Sta. Cruz at matagal ng binubuwisan ng aking nanay, at pinangalagaan sa pamamagitan ng kapatid namin na si Manuel na patay na ngayon.

9. **Q:** Do you have a copy of your mentioned tax declarations?

A: Opo, ito po ma'am ang dalawang tax declarations, isa para sa 2 hectares, at ang ikalawa naman ay para sa 8.9 hectares.

Counsel: Your Honor, the witness handed to this counsel a copy of the Tax Declaration in the name of Clenia V. Tajonera for as Lot 1306 (Part) Pls-22 with an area of two (2) hectares, and Lot 1305 (Part) Pls-22 with an area of 89,280 square meters, which we request to be marked as our **Exhibit "A and B"**, respectively.

10. **Q:** Aside from your mentioned tax declarations, what other proof do you have, in connection with the said claim of Clenia V. Tajonera over portions of Lot Nos. 1305 and 1306, Pls-22?

A: May mga naiwang papel po ang aming nanay na naitabi pa namin. Ito pong Kasulatan ng Bilihan ng Lupa sa Carlos Tria noong taong 1956 para sa Lot 1306, at ang Deed of Conditional Sale mula sa Amador Catama, Sr. noong taong 1958 para naman sa Lot 1305. Ito po ma'am.

Counsel: Your Honor, the witness handed to this counsel a copy of the said Kasulatan ng Bilihan ng Lupa and Deed of Conditional Sale, which we request to be marked as our **Exhibit "C and D"**, respectively.

11. **Q:** Where is this portion of Lot 1306 that you are claiming for the Heirs of Clenia V. Tajonera?

A: Ito po ma'am ay along the national road ng Brgy. San Vicente gaya ng ipinakikita sa Location Plan na ito na gawa ng taga-Assessor at sa latest na survey plan na ginawa ni Engr. Almero. Ito po ma'am ang dalawang sketch. Ang 1305 naman po ay katabi ng 1306.

Counsel: Your Honor, the witness handed to this counsel a copy of the said Location Plan and Sketch/Special Plan, which we request to be respectively marked as our **Exhibit "F and G"**. May we likewise move that herein Claimants be allowed to cause for the approval of survey in relation to their claimed property, similar in the cases of claimants Galsim, Hernandez, and Abeleda-Legaspi.

12. **Q:** You mentioned that these properties are declared for tax purposes in the name of Clenia V. Tajonera, who paid for the taxes thereof?

A: Matagal na pong binubuwisan ng aking nanay ang lupa, narito po ang naitabi naming mga resibo ng pagbabayad.


15. **Q:** Do you affirm the truthfulness and veracity of the contents of this Judicial Affidavit?

A: Yes ma'am.







PRAYER


WHEREFORE, premises considered, it is most respectfully prayed before this Honorable Court that a judgment be rendered:
