Respectfully forwarded is the memorandum from CENR Officer Anastacio A. Santos dated September 8, 2022 regarding the above-cited subject.

The cases for violation of PD 705 and RA 9175 were filed by the Mamburao MPS- PNP against Raymar V. Garcia but due to inadmissible evidence, the instant cases have been dismissed by the Office of the Provincial Prosecutor.

On the other hand, the Administrative Case was filed against the same person for violation of Section 77 of PD 705 as amended. On July 15, 2022 the preliminary hearing was conducted, the Hearing Officer Forester II Ariston SJ. Ramos recommends the forfeiture of the apprehended forest products and machinery in favor of the government.

COMPLETED STAFF WORK REPORT ON THE APPREHENDED UNDOCUMENTED FOREST PRODUCTS, IN VIOLATION OF SECTION 77 OF PD 705 AS AMENDED BY RA 7161 AND DAO 97-32, SERIES OF 1997

I. HISTORY

The case was filed against Mr. Reymar Villar Garcia, a resident of Barangay Balansay, Mamburao, Occidental Mindoro.

That on April 30, 2022, after they received an information from a concern citizen regarding an ongoing illegal logging at Sitio Cacawan, Barangay Balansay, Mamburao the complainants went there to verify the same. When they reached the place at about 4 o'clock in the afternoon, they saw respondent therein, along the lumber and chainsaw used.

Respondent could not present any documentation for the lumbers, which were determined to be of mango tree, and the chainsaw; hence he was arrested.

The subject logs were confiscated and turned over to the DENR-CENRO Sablayan Coordinating Office at Mamburao Occidental Mindoro.

On April 30, 2022, the accused was brought to the Office of the Provincial Prosecutor at Mamburao, Occidental Mindoro for inquest proceedings. The Associate Provincial Prosecutor recommended that the case undergo a regular preliminary investigation.

On May 11, 2022, The Office of the Provincial Prosecutor dismissed the complaint file against Mr. Reymar Villar Garcia for lack of evidence.

On July 15, 2022, the administrative hearing for the above apprehended illegal forest products was held at the DENR-CENRO Sablayan Coordinating Office. EMS Chief Ariston SJ. Ramos facilitated the hearing. The accused was present and was given the chance to explain himself.

OBSERVATION/FACTS

- 1. That during the Anti-Illegal Logging Operations of the Mamburao Municipal Police Station, they apprehended 28 bd. ft. of Mango species and a chainsaw inside Mr. Reymar Garcia's compound at So. Cacawan, Brgy. Balansay, Mamburao, Occidental Mindoro.
- 2. That when ask for proper documentation of the said logs and chainsaw Mr. Garcia failed to present one.
- 3. That on April 30, 2022, the accused was brought to the Office of the Provincial Prosecutor at Mamburao, Occidental Mindoro for inquest proceedings.
- 4. That on May 11, 2022, the case was dismissed for lack of evidence.

- 5. That as stated by the Associate Provincial Prosecutor's Resolution dated May 11, 2022, there is no probable cause for the police to arrest him. The police have neither caught him *inflagrante delicto* the mango tree into lumber using chainsaw, nor have they personal knowledge of the facts and circumstances that the person to be arrested has just committed the offense therefore, any evidence obtained during the apprehension will be inadmissible for any purpose in any proceeding.
- 6. That in the Administrative hearing conducted on July appeared and was given the chance to explain himself.

II. SUMMARY OF ADMINISTRATIVE PROCEEDINGS

It appears that the accused were caught by the Mamburao Municipal Police Station. He was caught in possession of undocumented forest products which is in violation of Section 77 of PD 705 as amended by RA 7161.

Section 77 clearly states that possessing forest products without proper documents or permit from the proper authority is a violation under PD 705.

III. RECOMMENDATION

Based on the above statement of facts and result of the complaint filed, it is hereby recommended that all forest products and chainsaw still be forfeited in favor of the government.







JOINT RESOLUTION

For resolution are the complaints of the MUNICIPAL POLICE STATION, MAMBURAO, OCCIDENTAL MINDORO against REYMAR GARCIA y VILLAR of Narangay Balansay, Mamburao, Occidental Mindoro for victorion of Presidential Decree No. 705, as amended, and of Republic Act No. 9175.

In support thereof are the: 1.) JA of PSSg Ricky E.Munar; 2.) JA of PSSg Bernard Cris Gonzales, Jr.; 3.) Inventory Sheet/receipt for PropertyGoods Recovered arrative Acknowledgment Receipt; and 5.) Pictures.

The instant cases were originally referred to this Office for Inquest Proceedings. However, in the resolution issued therefor, and for reasons cited therein, the undersigned recommended that the case undergo a regular preliminary investigation the case at bar.

From the complainant's submissions, it appears that on April 30, 2022, after they received a tip from a concerned citizen regarding an ongoing illegal logging at Sitio Cacawan, Barangay Balansay, Mamburao, this province, complainants went thereto to verify the same. When they reached the place at about 4 o'clock in the afternoon, they saw respondent therein, along with the lumbers and the chainsay used.

Respondent could not present any documentation for the lumbers, which were determined to be of mango tree, and the chainsaw; hence he was arrested. A DENR representative subsequently conducted an inventory of the lumbers and the chainsaw, and took custody thereof.

In his defense, respondent avers that he is the owner of the land were the lumbers and the chainsaw were found. He also avers that the subject lumbers were from his mango tree which was fallen by a past typhoon.

On April 25, 2022, he decided to have the place cleaned up so may use the land again with the aid of a mangyan volunteered to clean the place and to cut the fallen tree.

On April 30, 2022, while respondent, his wife, Armando Constantino, and Vergil Quiñones were preparing the land to plant banana, a policeman came and asked respondent whether he is selling the lumber. He replied that the same is owned by the mangyan who cleaned the area. Respondent was then asked if the chainsaw has a permit. Respondent replied that he doesn't know as the same is owned by the mangyan. The police then called a DENR representative. Armando Constantino was asked to power-up the chainsaw but it did not start. Respondent was then asked by the police to come closer to the lumbers and the chainsaw so they (police) may take his picture with the lumbers and chainsaw. He was thereafter brought to the station and charged with the instant cases.

Respondent pointed that the pictures presented by the police bolster his defense. It would be seen in a pictures that he is clean. Contrary to the police's allegation that they can be in the act of sawing the tree and in use of the chainsaw. Hence there is no probable cause for the police to arrest and charge him with these cases.

He filed pictures of the trees fallen by the past typhoon.

Witnesses Armando and Susan Garcia corroborates the material assertions of the respondence.

We find in favor of the respondent.

There is no contest that the lumbers are of a mango tree. However, we are more inclined to believe respondent's version of the story. That, the subject lumber where from a mango tree fallen by a past typhoon, which was subsequently made into lumber for economic reasons.

As we have earlier resolve during the Inquest Proceedings hereof, there is no probable cause for the police to arrest him. The police have neither caught him *inflagrante delicto* cutting the mango tree into lumber using a chainsaw, nor have they personal knowledge of the facts and circumstances that the person to be arrested has just committed the offense, as can be gleaned from the above-quoted statements.

We find it more plausible that the mango tree was fallen by a past typhoon, and were cut a week earlier than what is alleged by the police operatives. The absence of saw dust on the lumbers and its environs, as well as on the respondent, negates police's assertion that the offense has just been committed by the respondent.

The police operatives have neither witnessed in their presence that respondent has committed, is actually committing, or is attempting to commit an offense; nor had they personal knowledge of the with which to base probable cause that respondent offense. That being the case police have no landholdings of the respondent absent any warrant.

Section 2. The right of the people to be secure in their persons, houses, papers, and effects against unreasonable searches and seizures of whatever nature and for any purpose shall be inviolable, and no search warrant or warrant of arrest shall issue except upon probable cause to be determined personally by the judge after examination under oath or affirmation of the complainant and the witnesses he may produce, and particularly describing the place to be searched and the persons or things to be seized.³

Section 3. (1) $x \times x$

(2) Any evidence obtained in violation of this or the preceding section shall be inadmissible for any purpose in any proceeding. (Emphasis supplied.)

XXX

In as much as the lumbers and the chainsaw confiscated from the respondent stems from a violation of his constitutional right against unreasonable searches and seizures, the same is inadmissible in evidence in any proceedings, including the one before this Office.

WHEREFORE, premises considered, and the evidence being inadmissible, the instant cases are hereby DISMISSED.



May I have the honor to refer to your good office for appropriate action the herein attached criminal charges against Reymar Villar Garcia, 55 years old, married, farmer and resident of So. Cacawan, Barangay Balansay, Mamburao, Occidental Mindoro for Violation of P.D. 705.

FACTS OF THE CASE:

At about 3:30 PM of April 30, 2022, a phone call was received by Mamburao MPS from a concerned citizen informing that illegal logging activity was transpired at So. Cacawan, Barangay Balansay, Mamburao, Occidental Mindoro. Acting to the report, Intel personnel of Mamburao MPS led by PSSg Ricky Munar proceeded to the reported place to verify the veracity of the report resulting in the apprehension of Reymar Villar Garcia seized from their possession and control are Eight (8) pcs of 1x2x9, Four (4) pcs of 1x2x6 and Six (6) pcs of 1x4x6 with a total of Twenty-Eight (28) board feet of Mango Tree. The arrested suspect was appraised on their constitutional rights and brought to Mamburao MPS for documentation while the confiscated evidence was turned over to DENR/CENRO personnel for custody.
