OCCIDENTAL MINDORO

This is in relation to your Memorandum dated September 22, 2022, instructing the undersigned to comment under oath with supporting documents to the letter complaint of concerned CENRO employees of Sablayan, Occidental Mindoro dated July 21, 2022.

The said letter-complaint tagged and involved me in some alleged unbecoming conduct and some illegal activities in the exercise of my function as CENR Officer of DENR-CENRO Sablayan, Occidental Mindoro.

First, that I've shown impartiality and unfair selection in the hiring of new Forest Protection Officers. It is a fact that Forest Protection Officers (FPO's) are contractual employees, therefore they do not enjoy security of tenure. I did not in any way influence the selection of new FPO's. What I did was instruct every department under me to carefully evaluate old and new applicants for every contractual position and present them to me. We made sure that we did not violate any prohibitions in the hiring of new Contract of Services as provided by CSC Resolution No. 02070, Re: Policy guidelines for Contract of Services.

Second, that I uttered foul words against CENRO employees. The stated spoken words in the letter complaint, "Sino pa sainyo ang hindiko pa napapaiyak? Mas gusto ko sana lalaki naman ang iiyak" was uttered during a general meeting held in our office. The said phrases were uttered by the undersigned to lighten up the mood after reprimanding some DENR-CENRO employees for their unwarranted behaviors shown in the performance of their duties. I strongly believe that it is within my duty to reprimand and remind employees that failing to improve their performance will greatly affect the institution. Giving reprimands are a common practice in every government setting to avoid more disciplinary action.

Third, that I violate DENR existing standards on the construction of office infrastructures. Up to this date, no new infrastructures were introduced in our office. What I merely introduced is an initiative to clear out the office facade. When I assumed my office in DENR-CENRO Sablayan, you can't hardly see the frontage of our office. The compound was full of piled-up confiscated logs and conveyance, making it hard for us to entertain our clients and for the clients to easily see locate the office. The flag pole was also constructed poorly, near the entrance of the office. (Attached are the pictures of the old office façade versus the new façade)

Fourth, that I collect money from Travel Expenses Voucher (TEV) from CENRO employees. I do not take corruption accusations lightly. I did not in any way collect directly or indirectly any amount from travel expense vouchers from CENRO employees. When I introduced the initiative of improving the office façade and compound, I requested help from the section chiefs. Because of the beauty behind the initiative, each of them gladly extended their help to achieve the project. I even used my own money to fund the initiative and I do not expect anything in return. My money and their shares were also used to build fences around the existing storage facilities as our compliance with the Audit Memorandum (AOM) issued before to then CENRO Quebec sometime 2021. I found it urgent to construct the fences to properly preserve the confiscated logs and conveyances. (Attached are the pictures of old and new CENRO Central Forest Product Monitoring Station)

Fifth, that I solicit money from Environmental Compliance Certificate (ECC) holders of Sablayan. Again, I did not receive money from anyone. The office held numerous tree planting activities during my term. There are times when ECC holders extended their desire to give assistance by giving food to tree planting participants. I did not ask or request them to do so but their actions proved that they admire, support and trust the works of the institution. (Attached is a signed statement from all the ECC Holders of Sablayan)

Sixth, that I cut trees using a confiscated illegal chainsaw without the proper tree cutting permit and permit to operate chainsaw. When we introduced the initiative to fix the office façade and compound, we found it necessary to remove existing fruit trees (jack fruit trees) inside the compound using a confiscated chainsaw that was already issued confiscation order with finality.


Seventh, that I disrespect the Indigenous People (IP's) of Brgy. Aninuan, Puerto Galera.Brgy. Aninuan of Puerto Galera is not under my jurisdiction. I never received any request or communication from the said IP's nor visit their lands. It is very confusing to hear this matter for the very first time.

Eight, failure to follow office protocols for habitually submitting memoranda/communications directly to the Regional Office without informing or furnishing copy to the PENR Officer of Occidental Mindoro. I admit that I sent a number of communications directly to the Regional Office. Those are communications that I deemed to be confidential and in an urgent matter. But the PENR Office is provided with a copy.

Madam, there is always resistance when you introduce changes. I am aware that when I assumed the office last January, 2022, there was a lot of work to do. I am overwhelmed with numerous problems of the past administration. I know that bringing back the trust of the people in the institution is not an overnight job. Day by day I am discovering anomalous activities and in fixing them, I know I will not get the favor of everyone.

I already forwarded criminal and administrative complaints to the PENR Office and the Regional Office involving certain DENR employees but up until now, no recommendations and resolutions were made.

The 2017 Rules on Administrative Cases in the Civil Service (2017 RACCS), under Sec. 12 states that, "no anonymous complaint shall be entertained unless the act complained is of public knowledge or the allegations can be verified or supported by documentary or direct evidence." The complaint against me should be treated as an anonymous complaint. It is very



easy to put it under the name of "Concerned DENR-CENRO Sablayan". There were no signatures and supporting documents to prove their claims.

To clean my reputation, I am very much willing to be subjected to an investigation to show that the accusations against me are all baseless and fabricated. I have nothing to hide. In the name of justice and fair play, I urge the complainants to come out to substantiate their complaint.

Attached is a photocopy of the letter of CENRO Sablayan Employees dated August 25, 2022 expressing their personal dismay on the letter dated July 21, 2022 of the United CENRO Sablayan Employees which was submitted to the office of the Secretary.

This refers to the attached Letter-Complaint dated 21 July 2022 of the concerned CENRO Employees of Sablayan, Occidental Mindoro, received by this Department on 27 July 2022.

The complainants allege the following against you: 1) impartiality and unfair selection of Forest Protection Officers; 2) utterance of foul words against CENRO employees; 3) violation of DENR existing standards on the construction of office infrastructures; 4) collection of money from the Travel Expenses Voucher (TEV) of CENRO employees; 5) solicitation of money from Environmental Compliance Certificate (ECC) holders in Sablayan; 6) permission of cutting of trees using confiscated illegal chainsaw without the proper cutting permit and permit to operate chainsaw; 7) disrespect to the Indigenous People in Brgy. Aninuan, Puerto Galera; and 8) failure to follow office protocols for habitually submitting memoranda/communications directly to the Regional Office without informing or furnishing copy to the PENR Officer of Occidental Mindoro.

Pursuant to the authority under DENR Administrative Order (DAO) 2020-05, and as part of due process, you are hereby requested to submit to this Office within five (5) days from receipt of this Memorandum, your Comment under oath, with supporting documents, in response to the foregoing complaint.

SUBJECT: APPEAL ON THE PETITION TO REMOVE MR. ANASTACIO A. SANTOS FROM CENRO SABLAYAN OFFICE

The employees of DENR-CENRO Sablayan, Occidental Mindoro are expressing the utmost objection on the letter dated July 21, 2022 sent to your good office subjected as PETITION TO REMOVE MR. ANASTACIO A. SANTOS FROM CENRO SABLAYAN OFFICE citing the reasons such as weak leadership and management, impartiality, arrogance, corruption, and misused of public funds and lack of integrity as a public servant.

On the first paragraph, it stated that Mr. Santos showed impartiality and unfair selection of Forest Protection Officers when he did not consider the renewal of contract of some FPOs including FPO Noel Badeon and FPO Vincent Urbano who encountered gunfire/shooting from alleged illegal loggers while performing their duties.

We would like to clarify that the above-mentioned employees under contract of service status where given fair treatment as their applications for renewal were considered. However, the selection of new FPOs to be hired or rehired has undergone the process of interview made by the Deputy CENR Officer and Administrative Officer. The purpose is to determine not just their ability to apprehend and lift heavy lumbers but also to ascertain if they are well-knowledgeable about their duties including the understanding of the laws on forestry to ensure the proper and appropriate implementation of such, not to mention the reasons of alleged involvement of those personnel mentioned on the petition on the illegal activities reported by private individuals. We also believe that the present head of office has the prerogative to decide on matters within his ministerial and administrative jurisdiction.

On the second paragraph, it is stated that Mr. Santos showed misbehavior and arrogance and has been abusive in power and position to humiliate the personnel.

Please be informed that during meetings, all personnel were present and we witness every act and hear every words that the CENR Officer utters. We even have minutes of every meeting that we conducted that will prove his courtesy and respect towards that employees. Moreso, during meetings, he gave every employee ample time to report their accomplishments and raise issues and concerns so it may be resolved immediately. He even gives the highest resistance and best respect even to those employees who showed misbehavior.

On the third paragraph, it is stated that Mr. Santos committed corruption when he anomalously collected money from the amount of travelling expenses voucher claims (TEV) of some employees. It is also stated that he solicited money and in kind from the ECC holders in the Municipality of Sablayan during the conduct of tree planting and other office activities.

It is with deep respect to inform your office that we, the employees of DENR-CENRO Sablayan, finds no anomaly on the action that pertains to the TEVs of the employees and the voluntary assistance of ECC holders to our activities. There is no truth about the allegations that he collected money from TEV. What we remember is that he presented during one of our meetings the improvement of façade due to compliance to the instruction to transfer the confiscated lumbers to Yapang Central Monitoring Station located at Sitio Yapang, Brgy. Batongbuhay, Sablayan, Occidental Mindoro. He then asked for the assistance of the Section Chiefs and they committed financial assistance thru pledges from their claims of TEVs. What we know is that he only asked for help. The employees who committed their TEV claims deserves commendation. In fact, the huge percentage of amount utilized for the improvement came from the own pocket of the CENR Officer amounting to almost Php300,000.00. On the other hand, the assistance given by the ECC holders during our various activities were voluntarily given. The said ECC holders might be appreciative of the acknowledgement and recognition that this office is giving them which started during the term of CENR Officer Anastacio A. Santos.

The fourth paragraph emphasized the "failure and violations" of CENRO Santos when he made it possible that the concreting of office ground and parking was done in a very short period of time. For several years of being an employee of CENRO Sablayan, it is such a burden that frontyard of the office is not convenient for the employees and clients especially during rainy seasons. A nipa hut was also demolished as it became a hangout for

employees who are supposed to be working during office hours. A graelina tree was cut as it pose danger to the adjacent Day Care Center building especially when typhoon will occur. A bulletin area was constructed in order to comply with the office policy pertaining to allocated area for organizational chart, SECSIME/Citizen's Charter, and others. For a very long time, it is only now that the office of DENR-CENRO Sablayan is having its physical transformation which gives convenience to clients and conducive working environment to its employees.

On the fifth paragraph, it was mentioned that there was a same petition for Mr. Santos during his term as CENR Officer in CENRO Socorro, Oriental Mindoro. As professional employees of CENRO Sablayan, we do not indulge ourselves on matters that we are ignorant nor involved because we are not knowledgeable about the roots and causes of the issues raised against him. What important to us is that CENRO Santos is doing his job as CENR Officer of CENRO Sablayan effectively and with diligence and transparency.

The last paragraph stated that Mr. Santos failed to follow office protocols when he habitually submits memoranda/communications directly to Regional Office without informing or furnishing copy to the PENR Officer.

We do believe that CENRO Santos has been performing his duties knowing his limitations and observing proper protocols. An instance of submission of memorandum/communication directly to the Regional Office may have justifiable reason that can be clarified from the CENR Officer himself.

The last paragraph stated that "Public service must not be sacrificed by personal interest. This office wants a clear and readable roadmap that must be guided by reliable and credible leader. We want a leader who walk the talk, leaders by example and not the lousy one. A leader who do not work for money but instead for the many. How can we work happily if we have leaders who are not credible and lack of integrity?"

We, the true and genuine UNITED EMPLOYEES OF DENR-CENRO SABLAYAN, strongly denies the reliability of the petition made by unknown person/s. Please be informed that we are not consulted about the matter, we are not amenable with the content defaming the credibility of our current CENR Officer Anastacio A. Santos. We may be affected by his strict implementation of office policies, but since his first day of tenure, we all realized that he is just putting into effect the policies that must have been executed for a long time.

It is indeed true that public service must not be sacrificed by personal interest, and the current CENR Officer in the person of Forester Anastacio A. Santos possesses the same

principle. From the first day, we felt his sincere concern on the welfare of each and every employee. He even sacrificed his claims for travelling expenses in order to ensure that the employees will be able to enjoy the appropriate benefits that we deserve.

How do we define weak leadership under CENRO Santos? Is it determined by accomplishing the targets ahead of time? Is it determined by the positive changes on working attitude of employees who used to perform in just an average level into excellent one? Is it measured by the satisfaction and high approval of the clientele who proves that the present leadership only aspire services for many and not for money.
