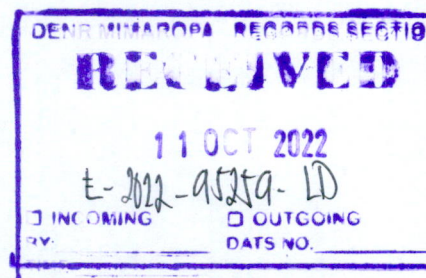



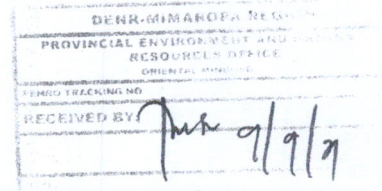

**SUBJECT** : **TEMPORARY RELEASE OF ONE (1) UNIT ISUZU JEEPNEY TOP DOWN WITH PLATE NO. DSR 420**



This has reference to the formal request forwarded to this office by Mr. Erving M. Ortega the registered owner of the Isuzu Jeepney top down with Plate No. DSR 420 which was apprehended by the elements of Philippine National Police (PNP) Victoria in Brgy. San Gelacio, Victoria, Oriental Mindoro containing undocumented Two Hundred Ninety Five (295) poles in June 13, 2021.

Pursuant to Section 9 of DAO 97-32, Temporary Release of the conveyance may be effected upon the suffice of the following;

1. Confirmation- This Office confirms thru the Hearing Officer that:
  - (i) the Official Registration papers and supporting documents are secured and made as integral part of the record of the case;
  - (ii) the applicant was not among those who were apprehended in relation to the case and is not a respondent in the case by virtue of which the conveyance is being detained "*pendente lite*";
  - (iii) the applicant has not previously been held administratively or criminally liable for violation of forestry laws, rules and regulation; and
  - (iv) the available evidence/s does not in any way indicate the complicity of the applicant in the offense cited in the confiscation proceedings.
2. Sworn Statement and Undertakings-The applicant Mr. Ortega has submitted a Sworn Statement and undertakings duly subscribed in August 2, 2021 in Victoria by Atty. Aristedes A. Maramot, stating the:
  - (i) precise nature of the claim of the conveyance;
  - (ii) declaration that he has not previously been held administratively or criminally liable for violation of forestry laws;
  - (iii) description of the lawful use to which the conveyance shall be applied during the pendency of the case;
  - (iv) replacement cost of the conveyance at the time of the application: amounting to Php 75,834.00 as appraised by the team of Committee on Provincial

Appraisal and Disposal of Properties led by the Chairperson, Myla Gemma P. Gamboa dated August 20, 2021;

- (v) Unconditional undertaking to return possession of the conveyance to the DENR as maybe required for the final disposition of the case.
- 3. Upon perusal of the submitted documents and explanation/clarification of the provision of DAO 97-32, the applicant willingly and voluntarily acceded to the posting of Cash Bond of Php 94,792.00 or equivalent to 125% of the declared replacement cost.

In view hereof, this office finds the request meritorious, hence inclined for the issuance of the desired Temporary Release Order.

Congruently, may we request the PENRO Accountant to accept the cash bond as payment for the temporary release of the conveyance.
