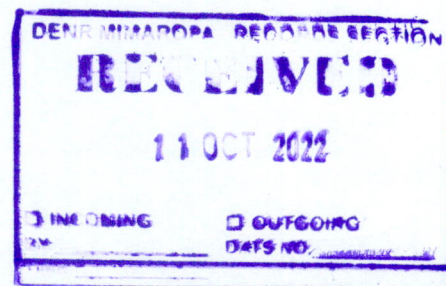

ANTECEDENT FACTS

In compliance with the provisions of DENR Administrative Order No. 97-32 [DAO 97-32], an **Administrative Adjudication Proceeding** was commenced relative to the above-cited subject and **Summary Confiscation Hearings** were scheduled by the undersigned hearing officer on **11 August 2022, 19 August 2022, and 07 September 2022** at DENR-CENRO Socorro, Brgy. Pasi II, Socorro, Oriental Mindoro.¹

The apprehending officers in this proceeding are **PCMS Glenn M. Monsato** and **PSSg Denis S. Dimapilis** of Pola Municipal Police Station [Pola MPS] while the respondent involved is **Jonnel M. Sabascar**, minority and a resident of Barangay Matulatula, Pola, Oriental Mindoro. The narration below and corresponding recommendation of the hearing officer, are based on the material and relevant pieces of evidence gathered from them.

Version of the Apprehending Officers

PCMS Monsato and PSSg Dimapilis heard the sound of an operative chainsaw while monitoring illegal activities in Barangay Matulatula at around 12:30 to 12:40 in the afternoon of 20 June 2022. When they proceeded to the area, they saw respondent in the act of cutting a Gmelina tree.

Respondent failed to provide for the necessary legal documents relative to the use of chainsaw and cutting of tree when asked by the apprehending officers. As a result thereof, respondent was arrested while the forest products and chainsaw without serial number were temporarily taken into custody by Pola MPS. The corresponding "Apprehension Receipt" was issued and the apprehending officers immediately coordinated with DENR-CENRO Socorro via electronic mail for the proper inventory and seizure of the above-named.²

Forester Kevin L. Corpuz of DENR-CENRO Socorro conducted the inventory, scaling, and marking of the lumbers and chainsaw at around 10:45 in the morning of 29 June 2022.³

A "Seizure Order" and "Seizure Receipt" were then issued by DENR-CENRO Socorro to officially take custody of the apprehended lumbers and chainsaw, with details to wit:⁴

C. EQUIPMENT / TOOL AND OTHER IMPLEMENTS

Chainsaw without serial number with estimated value of P30,000.00

Based on the Investigation Records submitted by the apprehending officers, there is a pending criminal case for Violation of PD 705, as amended against respondent docketed as **CRIMINAL CASE NO. CR22-11999**.⁵

Version of the Respondent

Respondent avers that the cutting of trees was already done when he was apprehended contrary to the statement of the apprehending officers. He was tasked by Vicente “Bembot” Malundras, owner of the property where the lumbers were gathered, to cut the latter for the construction of Bembot’s piggery.⁶

Josephine Malundras, wife of Bembot, submitted a letter asserting that the Sangguniang Barangay of Matulatula issued a “permit to cut” the Gmelina trees. Attached to the said letter is a copy of the alleged permit stating the following:

PAGPAPATUNAY

Sa Kinauukulan;

Ito ay pagpapatunay na si **JOSEPHINE M. MALUNDRAS**, naninirahan sa Barangay Matulatula, Pola Oriental Mindoro ay may DALAWANG (2) punong GEMELINA na matatagpuan sa Sitio Tanauan, Barangay Matulatula, Pola, Oriental Mindoro.

NOTE: Hinihiling na makapagpalagari ng may DALAWANG (2) punong GEMELINA upang magamit sa pagpapagawa ng piggery.⁷

As regards the seized chainsaw, respondent admitted that it is “assembled” and not covered with permit and that the owner/s of the Gmelina were not aware of such fact.

ISSUES

- (a) Whether or not the eleven (11) pieces of Gmelina shall be confiscated in favour of the government; and
- (b) Whether or not the “assembled” chainsaw shall be confiscated in favour of the government.

RECOMMENDATION

WHEREFORE, undersigned hearing officer, respectfully recommends the following:

- (a) **The Gmelina lumbers shall be confiscated in favour of the government and be disposed of in accordance with existing laws and procedures.**

Section 77 in relation to Section 77-A of Presidential Decree No. 705, as amended, otherwise known as "Revised Forestry Code of the Philippines," provides that:

Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products **without the legal documents** as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code.

xxx

In all cases of violations of this Code or other forest laws, rules and regulations, **the Department Head or his duly authorized representative**, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter. (Emphasis supplied)

Based on the records, no tree cutting permit was issued to respondent and spouses Malundras. The "Pagpapatunay" given by the Sangguniang Barangay does not constitute a valid permit to cut trees because such authority is conferred by law to DENR. Hence, the Gmelina in this case are illegal forest products subject to administrative confiscation.


- (b) **The "assembled" chainsaw shall be confiscated in favour of the government and be disposed of in accordance with the existing laws and procedures.**

Section 14, Paragraph 5 of DENR Administrative Order No. 2003-24 provides that:

Chainsaws used in cutting, gathering, collecting, removing and/or processing timber or forest products without legal documents shall be subject to judicial and/or administrative confiscation under Section 68 and 68-A of P.D. 705, as amended, and as implemented by DAO 97-32 and other subsequent forestry regulations that may be promulgated.

No Certificate of Registration of Chainsaw was issued to the respondent. Hence, possession and use of the involved chainsaw in cutting Gmelina trees are contrary to law and subject to administrative confiscation.

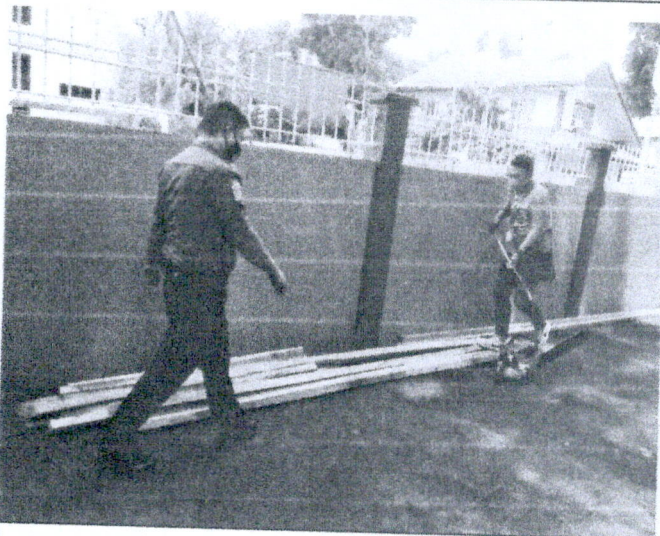
