Please be informed that on August 15, 2022 the undersigned together with Forester II Emma C. Francisco, Forest Technician II Elizalde M. Segundo, Forest Technician I Darius T. Jagmis and Forest Ranger Harlan A. Ilovino, coordinated to the barangay officials of Barangay Guadalupe, Coron, Palawan regarding the adoption of Multi-Sectoral Forest Protection supporting the anti-illegal logging operations of DENR-CENRO Coron, Palawan.

Forester II Emma C. Francisco introduced the Multi-Sectoral Forest Protection wherein this programme adopts not only within the area of jurisdiction of CENRO Coron but all over the Philippines. Pursuant to RA 7160 or the Local Government Code the LGU is also mandated to protect the environment and conserve the natural resources.

Forest Technician II Elizalde M. Segundo said that the purpose of MFPC is to have a proper coordination and resolution between the Barangays and Department of Environment and Natural Resources. This will engaged the barangay officials in monitoring of all illegal activities within their premises as they are the first to protect their area of jurisdiction.

Barangay Captain Enrico Sadang with his barangay officials agreed to adopt this resolution as they are willing to protect the remaining natural resources for the next generation. Some questions were raised during the meeting. This includes the issuance of cutting of trees. Forester II Francisco discussed the process of securing of cutting permits.

On August 17, 2022 another coordination to the barangay officials of Barangay San Nicolas, Coron, Palawan regarding this adoption of MFPC. The barangay officials are willing to adopt and support. It was agreed that they will brought this to their next session for their discussion and will submit the resolution as soon as said resolution will be approved.


