Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated September 22, 2022 relative the above subject.

Per memorandum, the apprehension was made on August 16, 2021 at around 4:00 P.M. during the conduct of random checkpoint by PNP-HPG along the National Road, Barangay Sta. Lourdes, Puerto Princesa City. The team flagged down and apprehended the Dark Blue Delica Van bearing Plate Number RAJ 319 loaded with 128 pieces of Ipil lumber (241.2 board feet) without the proper permit in violation of Section 77 of PD 705, as amended. The estimated fair market value of vehicle is Php70,000.00 while the Ipil lumber is Php36,000.00.

The owner of the vehicle on board is Mrs. Pacita Arancillo, the driver was Mr. Placido M. Rentura, Jr. together with two other helpers Carlo A. Castor and Hermes S. Andales. The said vehicle and its load were properly turned over by PNP-HPG to CENRO Puerto Princesa under the custody of For. Lim Bryan M. Kutat for safekeeping purposes.

Notices of hearings were sent to both parties and the hearing were conducted on November 16, 2021 and November 23, 2021 respectively at the Office of CENRO Puerto Princesa, Barangay Sta. Monica, Puerto Princesa City in relation to Item No. 1, Section 7 of DAO 1997-32.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended vehicle and forest product.



Respectfully submitted is the Summary of Administrative Confiscation Proceedings together with the pertinent documents anent the above –cited subject treated under DAO 97-32.

#### I. FACTS OF THE CASE

:

The Delica Van with plate number RAJ 319 owned by Mrs. Pacita Arancillo and driven by Placido M. Rentura Jr. travelling together along the national road of Brgy. Sta. Lourdes was flagged down by the PNP-HPG during their random checkpoint on August 16, 2021 around 4:00 in the afternoon. Upon inspection, they saw a pile of Ipil flitches loaded inside the vehicle. The officer asked for their permit however Mrs. Arancillo was unable to present any permit of her forest product. Then the member of PNP-HPG contacted this office for assistance where the said vehicle were turned over and delivered to CENRO office for proper disposition and custody.

Upon arrival at the CENRO office, Forester Kutat interviewed Mrs. Arancillo and her company regarding their identities. He learned that the three male person with Mrs. Arancillo were her relatives. FR Ryan Domondon conducted the inventory of the forest products then For. Kutat prepared an apprehension receipt and handed a copy to Mrs. Arancillo.

During hearing, Mrs. Arancillo admitted that she is the owner of undocumented Ipil flitches and also the vehicle used in transporting of such. Accordingly, those lumbers were aquired from the livestock delivery from Roxas and other municipalities. The delivery usually use those lumbers as flooring for the livestocks loaded on the truck and were sold to Mrs. Arancillo subsequently. She explained that those lumbers will be used in the supposed construction of small farm house in Barangay Bacungan.

#### II. NOTICE OF HEARING

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: rules for Administrative Adjudication of Illegal forest Products and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 7, Item #1, notice of hearing dated November 16, 2021 was sent to Mrs. Arancillo and her co-respondents for the conduct of administrative hearing on November 23, 2021 at the CENRO PPC office, Barangay Sta. Monica, Puerto Princesa City.

#### III. EVALUATION

Based on the above statement of facts, it is well settled and admitted by the respondent that she has no legal documents in the transporting of 128 pieces of Ipil flitches with a corresponding volume of 241.2 bd. Ft. at the same time the owner has an involvement in committing the crime. It is a violation of the PD 705 Sec. 77 which states that:

"Any person who shall cut, gathered, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with penalties imposed under Article 309 and 310 of the revised Penal Code..."

Based on the testimonies and evidence presented in this case, it was established that the owner of the conveyance was also on board during the apprehension. Hence, her participation in the commission of the offense cannot be denied.

#### IV. RECOMMENDATION

In view hereof, it is recommended that the One hundred twenty-eight (128) pieces of Ipil flitches having a total volume of 241.2 bd.ft. and Dark blue/silver Delica van with plate number RAJ 319 apprehended at Brgy. Sta. Lourdes, Puerto Princesa City be confiscaled in favor of the government.





