On September 08, 2022, the undersigned personnel conducted an orientation for the deputation of the members of Bantay Palawan Task Force and some members of the LGU-Barangay of Tagpait as Deputy Environment and Natural Resources Officer.

I. Training Title: Orientation-Training for Deputy Environment and Natural Resources Officer (DENRO)

II. Background and Rationale

Aborlan is politically subdivided into 19 Barangays. The municipality has a land area of 807.33 square kilometers or 311.71 square miles which constitutes 5.51% of Palawan's total area. It has more or less 40.8kha natural forest with only Five (5) Forest Rangers assigned from CENRO Office patrolling the vast forest land area of the municipality.

Since its inclusion to the jurisdiction of CENRO Puerto Princesa, several apprehensions were already made. LAWIN patrols recorded several threats such as timber poaching, kaingin and other forestry law violations.

According to the data of Global Forest Watch, from 2002 to 2021, Aborlan lost 1.42kha of humid primary forest, making up 23% of its total tree cover loss in the same time period. The total area of humid primary forest in Aborlan decreased by 5.4% in this time period.

The data shows that forest degradation continues, hence, the forest protection efforts in combating the rapid forest loss must be strengthened and a collaborative effort of different stakeholders is necessary to addressed this issue.

On May 19, 2002, a DENR-DILG Joint Memorandum Circular No. 2003-01, was issued. These agencies realized the need for the involvement of local government units (LGUs) in managing forestland resources in line with existing laws. The circular states that "the collaboration and partnership between DENR and DILG in supporting LGUs to protect, develop, and manage forestland resources will improve the overall health of the Philippine environment, uplift the socio-economic condition of upland communities, conserve biodiversity, strengthen food and fiber security, and stabilize the supply of water from watersheds. Various laws and policies call for the effective partnership between the DENR and LGUs. Republic Act No. 7160 otherwise known as the Local Government Code of 1991 devolved certain forest management functions to LGUs. DENR also issued Department Administrative Order No. 92-30 entitled "Guidelines for the Transfer and Implementation of DENR Functions Devolved to the Local Government Units." In 1998, DENR and DILG issued Joint Memorandum Circular No. 98-01 entitled "Manual of Procedures for DENR-DILG-LGU Partnership on Devolved and Other Forest Management Functions".

In compliance to the mandates of these issuances/orders, one of the initiatives that Local Government did was the creation of a taskforce. However, in the implementation of forestry policies especially filing of criminal cases in court for the violation of forestry laws, issues in deputation of their personnel arised.

Given the foregoing, it is very timely then that the Bantay Palawan Taskforce of the Provincial Government of Palawan requested for deputation of their Bantay Palawan Personnel as Deputy Environment and Natural Resources Officer (DENRO's). The Taskforce has been an active partner the CENRO PPC in conducting patrolling and apprehension of forestry law violators in the Municipality of Aborlan, and of the DENR in implementation of environmental laws in the entire province Palawan. With the manpower and resources of the LGU-Palawan and the technical knowledge of this Office regarding ENR laws, this partnership thru deputation will surely provide a great support in combating forestry and other environmental problems.

The orientation-training as the necessary requirement for the deputation was conducted thru the collaborative efforts of the Bantay Palawan Task Force, Barangay LGU of Tagpait and DENR CENRO.

III. Objective

The general objective of the orientation-training was to equip the Deputies of knowledge and information regarding relevant environmental laws, policies, rules and regulations implemented by the DENR.

- 1. The participants were given lectures, trainings regarding the following laws, rules and regulations;
 - a. Rule of Local Government in Forest Protection as espoused in RA 7160 or the "Local Government Code of the Philippines" and related policies;
 - b. ENR laws, DAO's and DENR Structure;
 - c. PD 705 or the revised Forestry Code of the Philippines;
 - d. DAO 97-32 "Rules for the administrative adjudication of illegal forest products and the machinery, equipment, tools and conveyances used in connection therewith";
 - e. DAO 2008-22 "Revised guidelines on the deputation of environment and natural resources officer";
 - f. Process of apprehension;
 - g. Lumber measurement; and
 - h. Other related ENR laws, rules and regulations.
- 2. Workshop community mapping of forest resources and current threats;
- 3. Pre-test and post test were used as an assessment tool; and
- 4. Role playing thru simulated apprehension for actual application.

V. Outputs

All participants from Bantay Palawan Task Force and Barangay LGU of Tagpait were able to complete the lecture/training session, took and pass the assessment test and were able to receive the certificate of participation.

VI. Participants

A total of 39 participants joined the training/orientation, 34 of them were members of Bantay Palawan Task Force (BPTF) and 5 were Barangay Official and employees of Tagapait, Aborlan, Palawan.

The members of BPTF who joined the deputation training was assigned at the Municipality of Sofronio Espanola, Rizal, Quezon, Narra and Aborlan, Palawan.

Hence, those assigned in different municipalities were given advice to coordinate to the CENR Office concerned who has jurisdiction over the area where they are assigned for the recommendation of the CENRO for their deputation.




Figure 2 Photo showing PB Dante Obar giving welcome message




Figure 8 Photo taken during apprehension role playing




Figure 17 Photo showing the materials provided by the CENR Office for the participants
