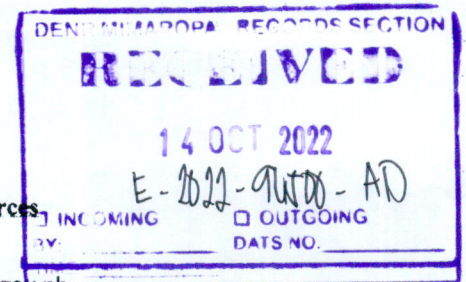

MANAGEMENT COURSE CLASS OF 2022

The Training and Development Division (TDD) of the Human Resource Development Service (HRDS) will be conducting the Environment and Natural Resources (ENR) Academy Management Course Class of 2022 this coming November at the ENR Academy, R.A. Padilla, Carranglan, Nueva Ecija.

Master's Degree holder or LLB/Juris Doctor graduate	He/She must be a graduate of at least any master's degree and/or LLB/Juris Doctor. Submission of a diploma shall be a pre-requisite for consideration.
Have not yet attended any of the following ENR Academy Courses: Specialized Courses, CENR Management Course (CENRMC), Resource Management Course (RMC), UP Program for Environmental Governance (UPPEG)	He/She is not a graduate of any ENR Academy Courses or related trainings conducted HRDS-TDD and its partner (UPPEG).
Physically fit to undergo training	He/She is physically able to attend training and participate in all its activities as certified by a government physician.
