Respectfully submitting the investigation report on the construction of causeway at the shoreline of Poblacion, Calatrava, Romblon. Said causeway is a project of the Department of Public Works and Highways, contracted by Sunwest Legaspi.

Inspection and validation undertaken revealed that reclamation activities have commenced, as the project shall occupy four thousand square meters (4000sqm) of the salvage and intertidal zone. It is recommended that a Cease and Desist Order may be issued and an Environmental Compliance Certificate (ECC) should be secured as per EMB MC 2014-005. Issued Certificate of Non-Compliance (CNC) –OL-R4B-2022-07-01162, dated July 1, 2022 should be revoked due to misinterpretation.

On October 6, 2022, the PENRO received 3 complaints namely a facebook post from concerned citizens of calatrava, compliant of Dr. Ronn Jon F. Fortu claiming the project is illegal since there is no PRA Clearance and no ECC, and Compliant of Hope in the Box (an NGO) calling the attention of the DENR regarding the causeway project and requesting copies of environmental permits, EIA and ECSC issued to the project.

On October 7, 2022, a team composed of the Chief, EMS-Romblon, OIC, Environmental Enforcement James Mendoza and Eric Hindap of Land Sector proceeded to the DPWH to inquire regarding said complaints. The team was met by Engr. Shem Tupaz, Project Engineer of DPWH DEO. She said that the project was issued a Certificate of Non Coverage (CNC). The project is the construction of a causeway with an approximate area of 4.000m² situated at the right side of the pier at shoreline. The team then proceeded to the LGU Calatrava and met with Vice Mayor Dashan Servañez. The vice mayor explained that they passed a resolution requesting the construction of shore protection near the pier but it was not specified in the resolution where the project will be placed. Upon initial development of the project, there were complaints of their constituents that the shoreline where they frequently visit for recreation is being threatened due to the development of the causeway. He added that there is no need for the causeway as shore protection since there is already a shore protection project in the area. In response, the LGU sent a letter to the DPWH dated September 5, 2022 requesting that the project be transferred at the other side of the pier near the cemetery since there is no shore protection at that side and that no one will complain if the project will be transferred at said site. Then the DPWH replied via letter Dated September 15, 2022 that they cannot grant their request for the following reasons:

- 1. Geo-tagged photos were submitted as one among the requirements prior to the release of funds, thus relocating the project would require approval from the department and would require technical justifications, resulting to extensive delay of the project.
- 2. Relocation of the project requires revision of the approved plan which will incur more 10% variance from original plan which may brought our designers liable to the penalties prescribed for violation of reasonable office rules and regulations.

In the same letter, the DPWH assured the LGU that their request for a causeway at the left side of the fish port will be included in their next regional budget proposal.

Then the team met Mayor Marieta Fabella-Babera. The mayor explained her stand that she would want very much to transfer the project. Engr. Shem Tupas explained that the management is considering terminating the project if the clamors continue. The Mayor replied that she would rather the project be continued rather than to terminate the project and that the completion of the project would not hinder their additional request for infrastructures for the municipality in the future. She added that when she visited the site, solid waste were abundant in the area and she had her people clean the site on the regular basis. It is better to develop the area than to leave it always littered with debris and garbage. She continued that her constituents tend to complain so much but once the project is finished those complainants will be the first to use the facilities. Engr. Tupas replied that their Office is considering to hold a final public hearing depending on the stand of the Mayor. She will report the stand of the Mayor to to the District Engineer for their further action.

Findings:

- 1. The Causeway is located at the right side of beside the port of the Municipality of Calatrava
- 2. It is a project of the DPWH District Engineering Office with Sunwest Legaspi as their contractor
- 3. The project is surrounded by Calatrava Bay at the North, Calatrava Shoreline at the East, Commercial and Residential Areas of the Poblacion at the South and Calatrava Pier and Fishport at the West
- 4. The area to be occupied by the project is approximately 4000m²
- 5. The project is situated at the shoreline beside the port particularly the salvage zone and intertidal zone.
- 6. Boulders were seen stocked at the intertidal zone along the northern edge of the project
- Two units backhoe were observed in the site.
 - 8. Steel rods were seen at the site
 - 9. The project was issued CNC –OL-R4B-2022-01162 dated July 1, 2022 for causeway projects without reclamation.
 - 10. Based on the plan, the whole 4,000m² of the project will be filled and concreted and used as parking space for vehicles boarding sea faring vessels at the Calatrava Port.

- 11. The filling up of materials at the intertidal zone is actually a reclamation activity contrary to the basis of the issuance of their CNC
- 12. As per EMB MC 2014-005, the establishment is required to secure an ECC.

Recommendation:

In view of the above findings, it is recommended that a CEASE AND DESIST ORDER be issued by the EMB Regional Director to the Causeway Project which will be lifted only upon securing an Environmental Compliance Certificate (ECC) and CNC –OL-R4B-2022-07-01162 dated July 1, 2022 be revoked due to misrepresentation.














Aternative Site for Causeway development at the left side of the pier

WHEREAS, per plans discussed by the DPWH construction section, the plan is to construct a causeway 40 meters from existing seawall to the sea and 100 meters in length from the existing fish port or 4,000 sq. meters and that the benefit is for a wide area of shoreline vacant space and the waves that might hit the properties beside the seashore will be protected from storm surges;



In this regard, we would like to inquire about Mandatory Requirement No. 3 which is the Area Clearance and Environmental Compliance Certificate ("ECC"). Kindly confirm if this Project was given the said requirements by your office, among others. Please note that this Project has already started but the greater population of "Calatravanhons" were not consulted prior to its commencement; resulting to the public clamour to stop or to relocate it to the western portion of the existing Calatrava Municipal Fish Port.

Section 5.4 of the IRR states that

XXX XXX

"No reclamation projects/components shall be approved by the PRA without the required Area Clearance and ECC to be issued by the DENR. Reclamation projects/components undertaken without the required ECC, Area Clearance and the approval of PRA Governing Board or the President of the Philippines shall be considered illegal and shall be forfeited in favor of the State without need of judicial action pursuant to Presidential Decree No. 3A."

It is clear that without the said requirements, the Project would be deemed "illegal". In relation to this, we would like to request your assistance on reviewing the legality of the said Project.

We hope for a favourable and speedy action on this matter.


