



• Revision of inconsistency in the following documents:

- o Project Components & Operation Information 1,219.68 sq.m;
- o LGU Certification 5,124.6 sq.m;
- o Project Description 5,124.6 sq.m;
- o Proof of Authority (Proof of application for SAPA) 5,124 sq.m; and

PEMAPS questionnaire - 5,124 sq.m;

Please note that the project size should be equivalent to the sum of the gross floor areas of structures plus the remaining open areas;

Summary matrix of the total gross floor area. Project / gross floor area shall be the sum / total of gross floor area of structures, plus open areas and other facilities (landscape, parking, pools, etc.);

Submission of the approved PAMB Clearance; and

• Whole copy of the SEP Clearance (must include all the pages of the clearance)

The paid processing fee may still be used within the calendar year of the payment date as outlined in EMB Memorandum Circular 2022-002, Section VIII.

This has reference to your Memorandum dated 22 June 2022 relative to the SAPA Application of Mr. Jorge dela Torre for the proposed Last Paradise Resort in So. Seven Commando, Brgy. Buena Suerte within El Nido-Taytay Managed Resource Protected Area (ENTMRPA).

In line with this, hereunder are our findings and recommendations as outcome of our review of the submitted documentary requirements:

- Lacking requirements for submission/compliance pursuant to DAO 2007-17
 - a. Project description supported by maps and pictures of the proposed area, development plan, timetable and description of activities from preparation to project implementation. The description should show sustainable management and development
 - i. This is the indicative development plan that provides general description of the project;
 - To include geotagged pictures of the proposed area;
 - iii. To specify timetable and description of activities indicating sustainable management per development phase
 - iv. Should be consistent with the Comprehensive Development and Management Plan (CDMP) and Site Development Plan
 - b. Environmental Compliance Certificate
 - i. For coordination with EMB
 - ii. Requires PAMB Clearance in the form of PAMB Resolution

c. PAMB resolution recommending the approval of SAPA application

 The proposed project was deliberated by the PAMB on 17 November 2021 and was received at the Regional Office last 23 June 2022.

ii. The entire set of PAMB documents has undergone review for approval and endorsement

- a. Comprehensive Development and Management Plan (CDMP)
 - i. General comments
 - 1. Follow the prescribed outline
 - Cite and provide references on the source of data/information using APA style
 - 3. Use reliable sources instead of Wikipedia
 - Check for typographical errors and proper casing, grammar and spacing.
 - 5. Ensure that maps and attachments are clear and readable.
 - ii. Specific comments
 - 1. Provide the following lacking parts:
 - a. Glossary
 - b. Name of Sitio (if applicable)
 - c. Date of CDMP
 - d. Gantt chart of activities for 25 years (Chapter 5)
 - e. Boundary and Maintenance (Chapter 5.5)
 - f. Other improvements (Chapter 5.3.3)
 - g. Returns (Chapter 10.3)
 - 2. For revision of content: refer to separate CDMP review template (attached)

Please be informed that the computed annual SAPA fee should be **PhP 3,529,105.00** instead of PhP 3,512,785.45 and should be revised in Chapter 9.1.1 of the CDMP.

Further, please be informed that per BMB Memorandum dated 10 June 2022, the acceptance of new applications for SAPA should be held in abeyance while the moratorium is in effect. The proponent/s who already submitted their SAPA application with requirements prior the issuance of instruction have the option to continue completion/compliance of the findings and lacking requirements in anticipation of the lifting of the moratorium. Meantime, application/s already received and reviewed by the Regional Office will only be endorsed to BMB once the moratorium is lifted and upon completion of requirements.

In this regard, you are hereby instructed to coordinate closely with the proponent for compliance of the abovementioned recommendations and orient them regarding the ongoing moratorium in El Nido.

Attached are the SAPA checklist/review guide with computation of user's fee and other pertinent documents for reference.
