Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated September 22, 2022 relative the above subject.

Per memorandum, the apprehension was conducted on September 18, 2021 at Brgy. Pasadeña, El Nido, Palawan by the Personnel of Monitoring and Enforcement Section of CENRO Taytay, Palawan. The team apprehended the two (2) units of topdown (EURO 150 Black and EURO 150 Blue loaded with eighty (80) pieces of Mangium lumber with an equivalent volume of three hundred eighty (380) board feet.

Please note that the issued Certificate of Registration No. DENR MIMAROPA REGION-12152018-011 had expired last December 20, 2018 and the respondent submitted their application for renewal of their Lumber Dealer Permit dated August 07, 2020. Since 2020, the respondent comply all the lacking requirements needed for the renewal of his permit.


Further, the Certificate of Registration for Lumber Dealer Permit was awarded on November 08, 2021 to the above-mentioned respondent the RHDD Lumber Trading owned by Mr. Harold Desquitado located at Barangay Villa Libertad, El Nido, Palawan.

We concur with CENRO recommendation to seek and forwarding the matter to the Regional Office for the review and disposition of the Mangium lumber and the Vehicles used.

This pertains to your memorandum dated January 26, 2022 relative to the above subject, please be informed of the following information to wit:

1. The apprehension was conducted last September 18, 2021 at Bgy. Pasadeña, El Nido, Palawan involving two (2) unit of topdown (EURO 150 Black with Engine No. 161FMJJ 1354550 and Chassis No. LF3PCK501UVF12763 and (EURO 150 Blue with Engine No. 161FMJJ1313423 and Chassis No. LF3PCK501JB810778) loaded with eighty (80) pieces of Manguim lumber with an equivalent volume of three hundred eighty (380) board feet.
2. On December 20, 2018, the issued Certificate of Registration No. DENR MIMAROPA REGION- 12152018-011 has expired and the respondent submitted their application for renewal of their lumber dealer permit dated August 7, 2020. The application was forwarded to your Office on October 16, 2020. Since 2020, the respondent comply all the lacking requirements needed for the renewal of his permit.
3. That on November 08, 2022, the Certificate of Registration for Lumber Dealer Permit was awarded to RHDD Lumber Trading owned by Mr. Harold Desquitado located at Bgy. Villa Libertad, El Nido, Palawan.

Please be informed that the apprehension conducted was legal in conformity to DAO 97-32. The undersigned is now forwarding the matter to the Regional Office for the disposition of the lumber and vehicles used. The issuance of Certificate of Registration for Lumber Dealer (CRLD) does not cure the illegal activities and it does not have retroactive effect as well.

Respectfully submitting is the memorandum report dated November 26, 2021 Forester II and Chief of Enforcement and Monitoring Section Dennis Aldrin O. Velasco relative to the above subject.

Please be informed that this Office conducted an administrative hearing last October 21, 2021 and November 23, 2021, respectively pursuant to Department Administrative Order (DAO) 97-32. The Hearing Officer recommends for the release of the two (2) units of topdown loaded with eighty (80) pieces of manguim with an equivalent volume of three hundred eighty (380) board feet.

Upon review and evaluation of the report submitted including its attachment, the undersigned does not concur with the recommendation of the Hearing Officer considering that during the apprehension of the mentioned forest products, the culprits has no any legal documents with them and the Lumber Dealer Permit (LDP) of RHDD was already expired and any forest products released for them is deemed illegal. It is noted that transport of lumber is considered illegal whether planted or not as provided under Presidential Decree (PD) 705. Section 8 of DAO 1994-08 also provides that any document presented without approved registered lumber dealer by the Regional Executive Director is deemed illegal. It is very clear during apprehension that the RHDD has no permit and the CENR Office does not issued any transport permit for RHDD to anywhere else.


