

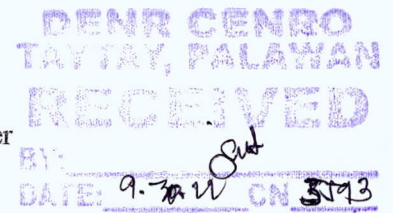

SUBJECT : **REPORT ON THE LEARNING EVENT CONDUCTED FOR THE NEWLY DEPUTIZED ENVIRONMENT AND NATURAL RESOURCES OFFICERS (DENROS) FOR THE MFPC ON LAW ENFORCEMENT FOR FOREST PROTECTION RESOURCES HELD AT DENR CENRO TAYTAY CONFERENCE ROOM, POBLACION, TAYTAY, PALAWAN**



This pertains to the above subject in relation to the target activity under “Activate/ revitalize MFPCs, individual and group volunteers for Deputization as DENROs.

Please be informed that the undersigned facilitated the learning event for the reorientation of DENROs for the Multi-Sectoral Forest Committee (MFPC) held at DENR CENRO Taytay Conference Room, Poblacion, Taytay, Palawan last September 23, 2022. A total of thirty-five (35) participants which included the secretariat attended the event. The program started with the prayer, followed by the national anthem and welcome remarks given by PENR Officer Felizardo B. Cayatoc. The salient features of P.D. 705 or Revised Forestry Code of the Philippines including the Criminal Offense and Penalties was discussed by Forest Technician I Voltaire M. Delos Angeles and the R.A. 9175 (Chainsaw Act) and R.A. 9147 or the Wildlife Act and Protocol on Wildlife Enforcement was discussed by Atty. Che Ann Mae Flores of the Palawan Council for Sustainable Development (PCSD). These concluded the morning session. In the afternoon, MGB embedded Francis Jade Cometa discussed the salient features of R.A. 7942 or the Philippine Mining Act. While DAO 97-32 or the “1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machineries, Equipment, Tools, and Conveyance” was discussed by the undersigned. A brief open forum followed where different scenarios were discussed regarding the use of quarry materials for personal use and the Office’s stand on this matter which was addressed by Mr. Cometa. Also inquired during the open forum were the transport and use of dismantled lumber from a known source. Other questions were regarding apprehension and the documentation of the said apprehension. Contacts numbers of personnel from the office were given after the open forum. Lastly the undersigned thanked the participants and asked for their continuous support in forest and environmental protection in the in the municipality of Taytay.

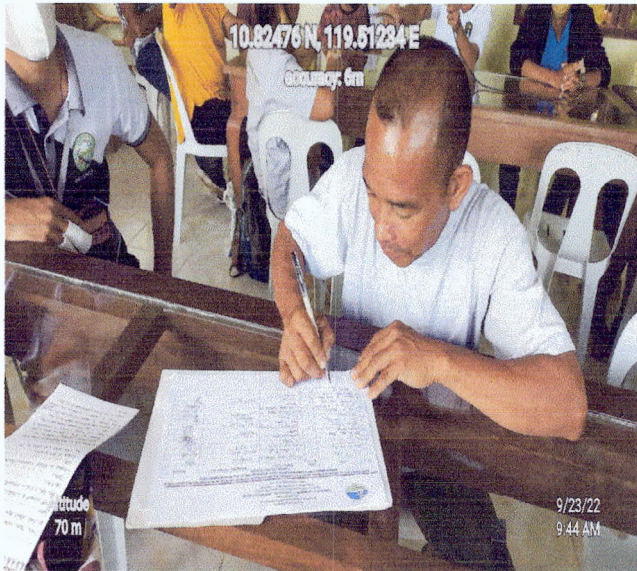
