
Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated September 27, 2022 relative to the above subject.

This pertains to the target for monitoring and evaluation of the implementation of ENR programs and projects including compliance with the existing policies and agreements under formulation and monitoring of ENR sector policies, plans, programs, and projects including the monitoring of existing Forest Land Use Agreement For Tourism (Flagt) Purpose of this Office.

In view hereof, please be informed that the following CENRO Taytay personnel representing Regulation and Permitting Section, Conservation and Development Section, Enforcement and Monitoring Section, and Environmental Management Bureau (EMB), LMO II Elvie G. Base, EMS Ana Liza D. Marasigan, Forester II Donna C. Tabernilla and Forest Ranger Herson Caliao and EMS I Nicath Trisha B. Enrile, respectively, monitored and evaluated the performance of Ten Knots Philippines Incorporated (TKPI) represented by Executive Director Ms. Mariglo Laririt, based on the terms and conditions stipulated in the agreement and performance evaluation sheet for forestry tenure at Pangulasian Island, Bgy. Bebeladan, El Nido Palawan. Hereunder are the findings and observations of the team, as follows:

- 1. That DENR Administrative Order No. 2004-28 dated August 25, 2004 and other existing laws, rules, and regulations promote, encourage, and develop tourism as a major national activity in which private sector investment, effort, and initiative are fostered and supported;
- 2. That FLAgT aims to develop the country's forestlands into productive uses consistent with the concept of sustainable development, provide economic opportunities to local communities and other stakeholders, ensure equitable share for the government on the use of forestlands, optimize the use of forestlands through sustainable management and to assure continuous beneficial uses and services of forestlands for the promotion and development of tourism without impairing their environmental and economic values;
- 3. That on December 27, 2005, the DENR awarded FLAgT No. DENR IV-MIMAROPA-12302030-0009 (Bathing establishment) to Ten Knots Philippines, Inc. (Ten Knots Development Corporation) with a total area of five (5) hectares located at Pangulasian Island, Bgy. Bebeladan, El Nido, Palawan;
- 4. That on August 24, 2022, the Compliance Monitoring Team conducted annual monitoring of the Forest Land Use Agreement For Tourism (Flagt) Purpose assisted by Ms. Mariglo Laririt, TKPI Executive Director, at Pangulasian Island, Bgy. Bebeladan, El Nido, Palawan;
- 5. That the holder failed to delineate, mark, and preserve the monuments and other landmarks indicating corners and outlines along the boundaries of the approved area, however, the holder has been committed to the conduct of relocation and delineation survey together with the Geodetic Engineer of this Office in compliance to the memorandum of Executive Director dated May 19, 2021.

- 6. That per site inspection, the villas and hotels are within the 40 meters easement zone which is prohibited under Article No. 51 of Presidential Decree 1067 also known as the Water Code of the Philippines states that the banks of rivers and streams and the shores of the seas and lakes throughout their entire length and within a zone of three (3) meters in urban areas, twenty (20) meters in agricultural areas and forty (40) meters in forest areas, along their margins, are subject to the easement of public use in the interest of recreation, navigation, floatage, fishing and salvage. No person shall be allowed to stay in this zone longer than what is necessary for recreation, navigation, floatage, fishing or salvage or to build structures of any kind. However, the approved area is subject to relocation and delineation survey to identify structures within the easement.
- 7. That the holder established the view deck and water storage facility outside the approved area which is prohibited under Section 17.1.3 of DAO 2004-28 states that the FLAgT may be suspended or canceled for occupation by FLAgT holder of an area greater or other than that covered by the management agreement. A letter dated February 26, 2021 signed by CENRO was sent to the TKPI Director received by TKPI Admin Officer last March 4, 2021, advising the holder to file an application for Special Use Agreement in Protected Area (SAPA) over the areas found to have structures outside the approved area. (Annex 1)
- 8. That the holder failed to install the billboard stipulated in the ECC general conditions no. 5 stating that a billboard containing this message: Notice to the Public, *This project "Pangulasian Island Resort" of Ten Knots Development Corporation has been issued an Environmental Compliance Certificate 9ECC-R4B-0905-102-9690) by the Environmental Management Buerau of the Department of Environment and Natural Resources, Region IV-B, on December 04, 2009.*
- 9. That upon inspection of EMS I Nicath Trisha B. Enrile, Chief EMS of the EMB, the holder failed to secure a discharge permit in violation of Republic Act 9275 also known as the Philippine Clean Water Act of 2004. Further, no proper storage and labeling on-site for hazardous waste.
- 10. The FLAgT holder failed to submit its annual report (CY 2021) as to its compliance with the approved Comprehensive Development Management Plan (CDMP) as stipulated in section 15 of DAO 2004-28. Further, the submitted CDMP is not approved.
- 11. That on March 19, 2022, the holder paid the annual government share to the Regional Office covering the month of December 2020 to December 2021 amounting to Seventy-Five thousand pesos (75,000.00) with Official Receipt No. 1412444. (Annex 2)

In view of the above findings and circumstances, the Compliance Monitoring Team respectfully recommends the following to wit;

- 1. Conduct a joint relocation and delineation survey before November 2022 in compliance with the memorandum dated May 19, 2021 of Regional Executive Director Maria Lourdes G. Ferrer. Subsequently, the identification of structures falls within the easement.
- 2. The Environmental Management Bureau (EMB) shall issue a Notice of Violation concerning the failure to secure the discharge permit.
- 3. The holder shall install Environmental Compliance Certificate billboard as stipulated in general conditions no. 5 of ECC-R4B-0905-102-9690.
- 4. The holder shall apply for an appropriate tenurial instrument on the area occupied that is outside the approved site and not covered by the management agreement.
- 5. The holder shall submit an annual report (CY 2021) and approved CDMP.

Attached herewith are the accomplished performance evaluation form for forestry tenure, map, and photo documentation of the monitoring activity.



Ferrer.

The holder established the view deck and water storage facility outside the approved area which is prohibited under Section 17.1.3 of DAO 2004-28, hence, the team advised the holder to apply for an appropriate tenurial instrument on the area occupied that is outside the approved site and not covered by the management agreement.

The holder failed to submit its annual report (CY 2021) to this Office, hence, the team advised the management to submit the same.




