

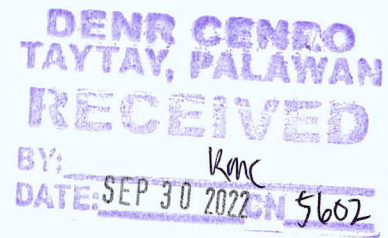

MAINTENANCE AND PROTECTION OF THE THREE HUNDRED  
FIFTY (350) HECTARES FOR CY 2022**



This pertains to the target activity of second year maintenance and protection (M&P) under the implementation of National Greening Program for CY 2022.

Please be informed that the undersigned together with the NGP-Extension Officers have conducted monitoring, evaluation and extended technical assistance to the fifty five (55) NGP family partners in Barangay Talog, Libertad, Pancol, Cataban, Liminangcong and Busy Bees all in the municipality of Taytay, Palawan. Activities made were geo-tagging and site validation of the established NGP plantations.

As per result of the monitoring all of the NGP family partners they have already accomplished the activities stated in the Supplemental MOA for maintenance and protection activities. They have conducted strip brushing, replacement of stake and replanting activities.

It was noted that there are mortality of planted seedlings especially the fruit tree and bamboo. Also some of the planted fruit trees are s5-tunted in growth, thus we have advised them to apply fertilizer to boost the growth of the seedlings. We have also advised each NGP family partner to maintain a nursery beside there plantations to have a source of seedlings to be used for replacement for mortality.

Upon verification of the surveyed NGP areas some of the planted seedlings are falls outside the shapefiles, thus updating of maps will be conducted on October up to November 2022.

Further all of the 55 NGP plantations have been inspected by the CENRO inspection team for the third (3<sup>rd</sup>) quarter maintenance and protection activities. Below are the list of inspected partner/contractors with area maintained, location and survival rate.
