Building Committee Resolution No. 2022-0_2

"DESIGNATING 'DENR BY THE BAY BUILDING' AS THE OFFICIAL NAME OF THE BUILDING LOCATED AT 1515 ROXAS BOULEVARD, BRGY. 668 ERMITA, MANILA"

WHEREAS, the Department of Environment and Natural Resources (DENR) is the owner of five (5) parcels of land containing a total area of One Thousand Four Hundred Eighty-Four and 6/100 (1,484.60) square meters, with a ten (10) storey building, located at 1515 Roxas Boulevard, Ermita Manila and covered by Transfer Certificate of Title (TCT) No. 175864;

WHEREAS, the building located at 1515 Roxas Boulevard, Ermita Manila has been referred to as "L&S Building" by the previous private owner;

WHEREAS, since the purchase of the building on 31 August 1982, there has been no law or enactment formally assigning a name for the building located at 1515 Roxas Boulevard, Manila;

WHEREAS, the Natural Resources Development Corporation (NRDC) is designated as the Building Administrator of the "L&S Building" by virtue of the Memorandum of the Undersecretary for Management & Technical Affairs dated 17 November 2003;

WHEREAS, a Building Committee is created pursuant to Memorandum of the Undersecretary for Management & Technical Affairs dated 17 November 2003, composed of the Administrative Officers (AOs) of respective DENR Offices. They shall work closely with the designated Building Administrator and shall be responsible for the implementation of activities and projects in the improvement of the workplace.

WHEREAS, the Building Committee is composed of the following DENR Offices (bureaus and agencies), presently occupying the building:

- Department of Environment and Natural Resources (DENR)-MIMAROPA Regional Office;
- 2) Department of Environment and Natural Resources (DENR)-NCR-Metropolitan Environmental Office West (MEOW);
- 3) Environmental Management Bureau (EMB) CALABARZON;
- 4) Environmențal Management Bureau (EMB) MIMAROPA;
- 5) Mines and Geoscience Bureau (MGB) CALABARZON;
- 6) Mines and Geoscience Bureau (MGB) MIMAROPA; and
- 7) Natural Resources Development Corporation (NRDC)

WHEREAS, it is necessary and important to have a common property identification and to establish a uniform name of the building owned by DENR located at 1515 Roxas Boulevard, Ermita, Manila;

NOW, THEREFORE, LET IT BE RESOLVED, AS IT IS HEREBY RESOLVED, that the building located at 1515 Roxas Boulevard, Manila to be known and identified as "DENR by the Bay Building."



RESOLVED FURTHER, that the address shall now read as follows "1515 DENR by the Bay Building, Roxas Boulevard, Barangay 668 Ermita, Manila."
