ON AUGUST 08, 2022.

This pertains to the Secretariat meeting of the San Vicente Flagship TEZ (SVF TEZ) held last September 08, 2022 at the 2<sup>nd</sup> floor Conference room of Tieza Office in San Vicente. The undersigned with FT Rea C. Garcia attended the meeting to represent the DENR as one of the members of the SVF TEZ. In the meeting, the following were discussed together with the other agenda, such as: 1) Updating of the CLWUP/FLUP of San Vicente; 2) Inspection for permit issuance on the Mangrove Boardwalk.

Based on the presentation of the San Vicente LGU, the Comprehensive Land and Water Use Plan (CLWUP) is in the final phase to which the undersigned emphasized the need to fast track the updating of the San Vicente Forest Land Use Plan (FLUP) which is yet to be adopted and currently under review for data updates and simultaneously with activities in the same day, also attended by the undersigned and other CDS personnel, ECOMS I Jane M. Juarez, ECOMS I Jo Annie D. Corvera, FT I Rea C. Garcia. The Secretariat assured the integration of the FLUP as it is an important component to the CLWUP.

For the Mangrove boardwalk project, the secretariat was reminded of the SEP law (RA 7611) which classified all mangrove forest in Palawan as **core zone** or no touch zone and was emphasized by the PCSD representative as the lead implementor of the law. However, to consider a possible favorable action on the matter, the undersigned informed the secretariat of the creation of CENRO inspection team who shall conduct the inspection. They were also advised to seek the approval/recommendation of the PCSD main Office as it is an important component to the acquisition of any permit especially in Palawan.

Observed during the meeting was the lawful exclusion of claimed forestland from their priority area for investors as recommended by the DENR during earlier phase of the program.

In view of the above, the following are recommended:

- 1. Joint inspection of CENRO Inspection team, PCSD, and LGU of San Vicente for more dignified and credible results.
- 2. Continuous close coordination with the SVF TEZ to reassure the integration and upholding of all existing forestry and environmental laws in all processes of the program.
