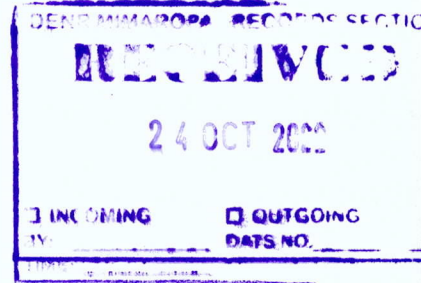

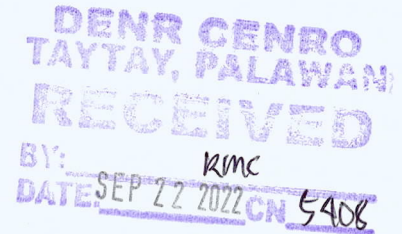

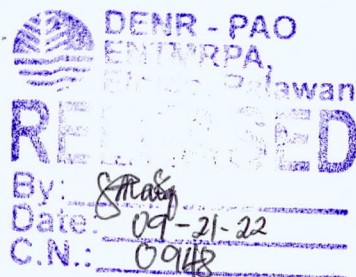


Respectfully forwarded is the memorandum dated September 6, 2022 from Park Maintenance Foreman Jenuel P. Casel regarding the above subject.

During the meeting the topic focused on the removal of stranded yacht, schedule of removal and the location where to sink the yacht to be use for recreational dives.

Based on the report, the attendees concurs with the recommendation to conduct inspection on the yacht as well as to propose area for sinking to manage environmental disturbance.

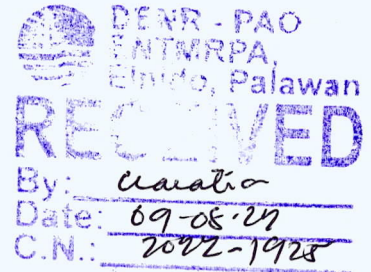

SUBJECT : MEETING ON THE PROPOSED EXTRACTION/REMOVAL OF STRANDED YACH ALONG THE BEACH AREA OF BARANGAY MASAGANA, EL NIDO, PALAWAN



Please be informed that on September 5, 2022. The undersigned represented the PAMO to a meeting stated on the above subject. The meeting was participated by Coast Guard El Nido, Naval force, Municipal Tourism Office, Municipal Environment Office, Divers association, Pump boat operators association and representative from Mayor's Office. The meeting was spearheaded by Mr. Tani Distal and the PCGA-405th Squadron. Mr. Distal earnestly requesting the urgent removal of the stranded yacht to prevent danger and hazard to lives and property especially north east monsoon is approaching. For brief information the yacht was stranded during the devastation of typhoon Odette on year 2021. In any means private sector is cooperative on the said activity and willing to support the logistic and manpower.

Further, coast guard personnel discussed the proper procedure for extraction and salvage operation that clearance and permit shall be first secured. Othermore, tentative schedule for removal of the stranded yacht is on September 9-10, 2022 since highest tide shall be experienced on this date. Due to the permits and clearances to be secured the activity was not possibly pursue. Recommended further, that the tourism office may in charge on the processing of the required documents and to coordinate to the yacht owner and informed the proposed activity. On the meeting, discussed also the location where to sinked the yacht and purposely used for recreational dives. Recommendation also rises to conduct inspection on the yacht and to the proposed area for sinking to manage environmental disturbance.

Lastly, the MTO was advised to update the participants of the meeting on the status of the required documents for further planning and coordinating. Moreover, policies and regulation on the Protected Areas for this activity shall be disseminated and considered.


