This has reference to the Order of Investigation dated September 29, 2020 issued by then Regional Executive Director Maria Lourdes G. Ferrer, CESO IV relative to the case of Nenita Gomez Regla, et al., represented by Nenita G. Regla versus Homestead Patent No. NRD-IV-26-1180, Original Certificate of Title (OCT) No. 2741 Edgardo Vasquez, et al. involving Lot No. 252, Pls-529 situated in Barangay Simpocan, Puerto Princesa City with an area of 44,529 square meters.

On February 22, 2021, the CENRO Puerto Princesa City requested for clarification on the above issued Order of Investigation whether their Office has jurisdiction to investigate titled properties considering that the cancellation/reversion of titles as prayed for by the petitioners is within the jurisdiction of the Honorable Court.

This Office answers in the affirmative. The DENR has the jurisdiction to investigate petitions involving registered patents and titled properties as provided for under Chapter III of DAO 2016-31. The proceeding under this Chapter shall be merely investigative in nature which will be conducted as a fact-finding/recommendatory procedure to determine the propriety of initiating reversion proceedings.

Sections 27 and 28 thereof provide that an investigation may be initiated by the RD2 motu proprio (office-initiated investigation) or upon the filing of a Petition by any other person on the ground among others, that the patent was procured through fraud and/or misrepresentation.

Based on the foregoing, the Order of Investigation dated September 29, 2020 directing the CENR Officer of Puerto Princesa City to select a Land Investigation Officer (LIO) to conduct actual investigation and ocular inspection, and thereafter to submit the corresponding report as required under DAO 2016-31, is hereby reiterated for your immediate compliance.
