



This pertains to our target on item 2. 2nd year (2022) Maintenance and Protection Activities of the Enhanced National Greening Program (ENGP) CY 2021- Agroforestry Plantation and Central-Based Fund Bamboo plantation.

Please be informed that the IAC Team I conducted inspection, validation and assessment for the fourth cycle maintenance and protection activities of NGP family partners in Barangays Libertad, Talog and Pamantolon all in Taytay, Palawan on September 6-9, 13-16 & 20-23, 2022. The inspection was conducted in response to their letter request for inspection.

The contractor with the assistance of assigned Forest Extension Officer (FEO) conducted replanting of dead seedlings, fertilizer application and conduct of deterrent activities to prevent other forms of destruction through foot patrol.



Plantations with a survival rate of less than 85 percent are those areas that were severely affected by the recent typhoon “Oddette” where numerous trees obstructed the strips and the branches covered the planted seedlings. However, the partners are trying to replant all dead seedlings to ensure high survival rate before the end of the year.

On the other hand, the team noticed that there were plantations where the planted coffees were stunted probably due to the lack of nutrients and the frequent rains that were not favorable for this kind of species. Therefore, the team recommends adding more fertilizer and expanding ring weeding to boost the growth of the plants. However, there were plantations that the coffee seedlings were grown healthy particularly the plantations of Mr. Jonathan Villorente and Mr. William V. Sonio which were less affected by the typhoon.

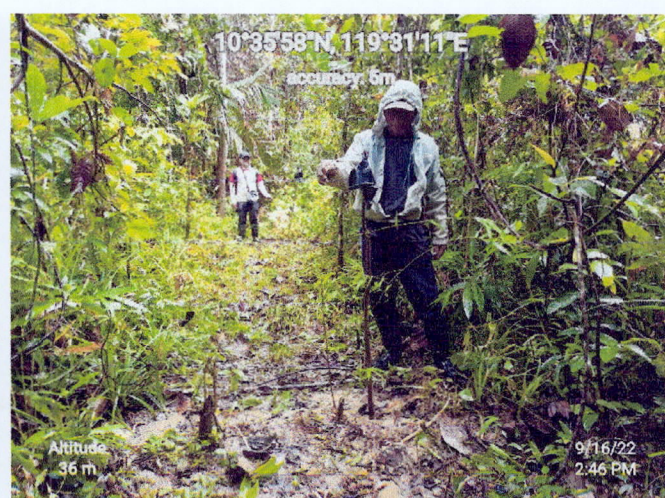
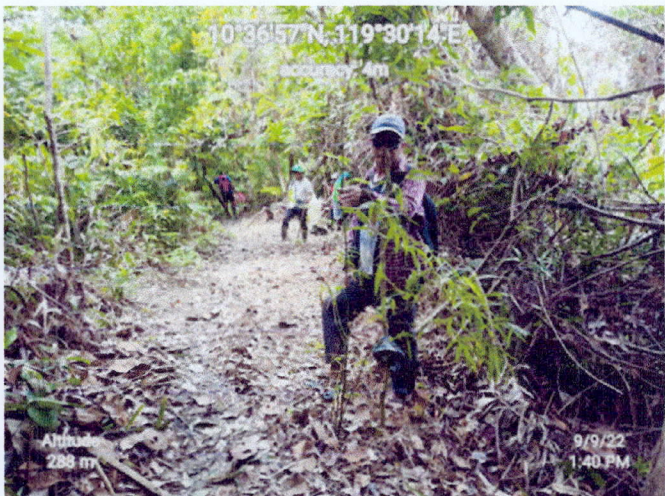
