OBSERVATIONS AND INVESTIGATION:

- 1. That we made casual conversation together with the actual occupant for the said purpose
- 2. That the office send them a notice to vacate if not mistaken last July 2021.
- 3. That we observed that they did not self-demolished even they received first notice to vacate
- 4. Reiterate to them, that their occupancy is illegal based on PD 1067 section 51.
- 5. That all of constructed their houses along the shore line but within forty (40) meters easement zone.
- 6. That the team observed that their domestic waste are directly disposed to the sea.
- 7. That no proper waste disposal.

ACTION TAKEN:

 We had conducted a casual dialogue and explained with those people together with Kagawad Mora about the above issue.

 Explained to them the RA 9003 which is Solid Waste Management, PD 1067 Water Code of the Philippines and RA 9275 Philippines Clean Water Act of 2004.

RECOMMENDATIONS:

We highly recommend that which is violation of Article 51 of PD 1067 all of them must to self-demolish in the area and issuance of notice to vacate for the second time since their occupation/possession within forty (40) meters easement zone. Conduct Information Education Campaign (IEC) for the information of the community and nearby communities. Composition of multi-sectoral team for their findings base to their mandates. Closely monitoring in coordination operation with other enforcement agencies.
