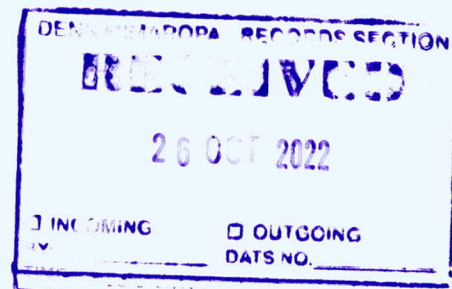

ANNUAL NATIONAL CONFERENCE**



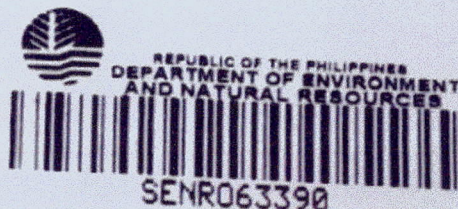
