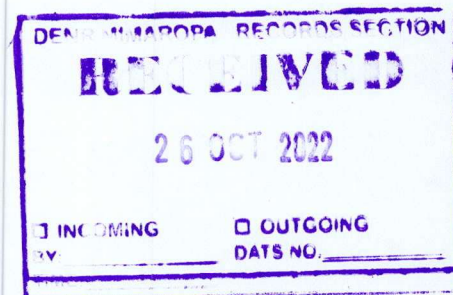


In connection with the above cited subject, please be informed that the undersigned personnel conducted monitoring of the imported Malaysian lumber delivered to Mr. Robert Tee Uy of Prima Enterprises in Brgy. Lalud, Calapan City, Oriental Mindoro from Genmart Wood Development Corporation at Brgy. Lambakin, Marilao, Bulacan.

During our monitoring, a total of four hundred eighty eight (488) pieces of Malaysian lumber with an aggregate volume of 6,932 board feet or 16.35 cubic meter were inventoried in lumber yard of Prima Enterprises. Compared to previous inventory conducted on September 15, 2022 which registered 8,445 board feet or 19.92 cubic meter, thus a total of 1,513 board feet or 3.57 cubic meter were sold/disposed.


