**COMPLETED STAFF WORK REPORT (CSW) ON THE APPREHENDED
UNDOCUMENTED FOREST PRODUCTS, VIOLATION OF SECTION 77 PD 705 AS
AMENDED BY RA 7161**

I. HISTORY

The case was filed against Mr. Christopher C. Genata, a resident of Barangay Poblacion, Sablayan, Occidental Mindoro.

That on June 20, 2022, the joint anti-logging operation conducted by the DENR-CENRO Sablayan and Sablayan Municipal Police Station resulted to the arrest of Mr. Christopher C. Genata who was caught transporting undocumented forest products at Sitio, Punta, Barangay Poblacion, Sablayan, Occidental Mindoro using a blue motorcycle with sidecar (RUSI125) with plate number 1282 VI.

During the apprehension, it was found out that the accused was found transporting 27 pieces of Anapla with a total volume of 101.75 bd ft. He asked if he have a permit to carry the said lumber and he answer in the negative.

The accused was arrested and brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for inquest proceeding.

On June 20, 2022, the San Jose, the San Jose Regional Trial Court issued an information against Mr. Christopher C. Genata for the Violation of Section 77, PD 705. The case was docketed as Criminal Case No. R-11340.

The administrative hearing for the above apprehended illegal forest product was held on July 19, 2022 at DENR-CENRO Sablayan Main Office, EMS, Chief- Forester II Ariston SJ Ramos acted as the hearing officer, assisted by Asst. Chief, EMS, Jeremy Russel A. Saracanlao. The accused was present and was given the chance to explain himself.

OBSERVATION/FACTS

1. That on June 20, 2022, the joint anti-logging operation conducted by the DENR-CENRO Sablayan and Sablayan Police Municipal Police Station resulted to the arrested of Mr. Christopher C. Genata who was caught transporting undocumented forest products using blue motorcycle with sidecar (Rusi125) with plate number 1282 VI.
2. That during the apprehension, it was found out the accused was transporting undocumented forest products (27 pieces of Anapla)
3. That transporting undocumented forest products is a crime under Section 77 of PD 705 as amended by RA 7161.
4. That the administrative hearing Mr. Christopher C. Genata admitted transporting the said undocumented forest products. According to him the apprehended Anapla lumbers are from Brgy. Sto. Niño, Sablayan, Occidental Mindoro.
5. That according to Mr. Genata he planned to use the apprehended Anapla lumber to build for furniture.
6. That the accused was arrested and brought to the Office of the Provincial Prosecutor San Jose, Occidental Mindoro for inquest proceeding.
7. That an Information was issued against the accused on June 20, 2022. The case docketed as Criminal Case No. R-11340.

II. SUMMARY OF ADMINISTRATIVE PROCEEDINGS


It appears that the accused was caught in transporting undocumented forest products which is in violation of Section 77 PD 705 as amended by RA 7161.

Section 77 clearly states that transporting forest products without proper documents or permit from the proper authority is a violation under PD 705.

III. RECOMMENDATION

Based on the above statement of facts, administrative hearing and criminal case filed, it is hereby recommended that all forest products and conveyance be forfeited in favor of the government.




INFORMATION

The undersigned **CHRISTOPHER GENATA y Catalino**, of Violation of Section 77, of PD 705, committed as follows:

That on or about the 20th day of June, 2022, at around 5:45 o'clock in the morning, in Sitio Punta, Barangay Poblacion, Municipality of Sablayan, Province of Occidental Mindoro, Philippines, and within the jurisdiction of this Honorable Court, the accused, with intent to gain, did then and there, willfully, unlawfully and feloniously, have in his possession, custody and control eight (8) pieces 2x6x7, ten (10) pieces 1.5x5x3 and nine (9) pieces 1.5x8x3, all Anapla lumber, with total volume of 101.75 board feet, amounting to FOUR THOUSAND FIVE HUNDRED SEVENTY EIGHT PESOS AND 75/100 (P4,578.75) Philippine Currency, loaded in a RUSI 125 motorcycle with sidecar, colored blue, with Plate No. 1282 VI, without any permit or authority from the Secretary of Environment and Natural Resources or his duly authorized representative, in violation of PD 705 as amended, to the damage and prejudice of the Philippine Government.







FACTS OF THE CASE:

On the aforesaid time, date and place, joint Anti-Illegal Logging Operation was conducted by the personnel of this station under the supervision of the undersigned together with the DENR-CENRO Sablayan, Occidental Mindoro which resulted to the arrest of the above-named suspect. Recovered from the suspect immediate possession while on board a Blue Rusi TC125 motorcycle bearing no plate number with side car used for transporting the Twenty Seven (27) pieces Anapla Lumber with a total of One Hundred One and Seventy Five (101.75) board feet with estimated value amounting to Four Thousand Five Hundred Seventy Eight pesos and Seventy Five Centavos(Php 4,578.75). Upon demand, the suspect failed to present Permit to Transport of the said lumbers. Thereafter, arrested suspect was apprised of his Constitutional Rights (Miranda Warning and Anti-Torture Law). Consequently, the recovered pieces of evidence were inventoried and scaled by the personnel of DENR-CENRO Sablayan, Occidental Mindoro and further brought to this station for proper disposition.


