Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated October 17, 2022 relative the above subject.

Per spot report, the apprehension was made on October 15, 2022 at around 8:30 A.M. by MES Personnel of CENRO Quezon, PCSDS Enforcement Team (DMD South) and MBLT4 in response to the received information that there were piled of Ipil lumber covered with coconut leaves near the warehouse of a certain Bonbon Bundal. The team immediately proceeded in the area and apprehended the 125 pieces of Ipil lumber and 12 pieces of Binuang lumber with a total volume of 1,844.8 and 77.54 board feet respectively at Sitio Natutungan, Barangay Quinlogan, Quezon, Palawan.

The apprehended lumbers were hauled and deposited at CENRO Quezon compound under the custody of DENR CENRO, Quezon, Palawan for temporary safekeeping and to be followed by administrative confiscation proceedings in accordance with DAO 1997-32.

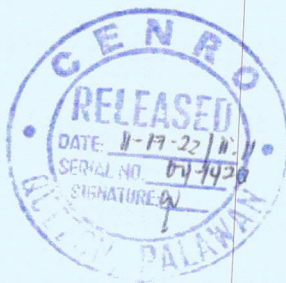

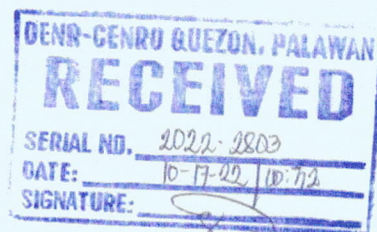

This pertains with the apprehended 137 pieces Ipil and Binwang lumber with a total volume of 1, 922.34 board feet at Sitio Natutungan, Bgy. Quinlogan, Quezon, Palawan.

Please be informed that on October 15, 2022, at around 8:30 in the morning the team received an information from the enforcement unit of Palawan Council for Sustainable Development Staff (PCSDDS) that there were undocumented Ipil lumber piled near the bodega of a certain Bonbon Bundal in So. Natutungan, Bgy. Quinlogan, Quezon, Palawan. The team immediately proceeded to the subject area and found the said lumber. It was scattered within the area and covered with some coconut leaves and it was scaled and inventoried by the team. A total of 1, 922.34 board feet of Ipil and Binwang lumber were apprehended by the joint operation of this Office, PCSDDS, DMD South and MBLT4.




