Dear Mr. Ramos:

This has reference to your letter of September 19, 2022, requesting for the inspection of Lot 222-Pls 14 where the residential houses of the members of the association are located/erected. Also, the purpose of site inspection is determining the present relative position of Sabang River to the said lot.

Based on the site inspection last September 27, 2022, in the presence of the representatives from the Local Government Unit of Sablayan and in the Office of the Provincial Governor, the following observations were accounted:

1. The Sabang River, using the description appeared in the from the residence of **Ms. Atanacia Uy**, Block 3. Lot 23. But, in the actual condition the width of the river has decreased/reduced substantially from estimated 174.0 meters to 26.0 meters, see attached Annex A;

2. The difference between the estimated and present width of the river of about 148.0 meters is a vacant lot formed thru accretion process and predominantly dominated with mangrove species, see attached Annex B and;

3. Further, it can be gleaned in the same picture as Annex B – the perimeter of the lot/property is very far from the relative position of the river.

Premises considered, the property is not covered by the provisions of Presidential Decree No. 1067 or Water Code of the Philippine on easement requirement.

Hope with this explanation, the concern of the association has been addressed properly by this office.
