

LAYLAY, BOAC, MARINDUQUE.

In compliance with your directive relative to the above-noted subject, respectfully forwarded to you herewith is the Re: Investigation Report of the case dated March 3, 2022, for evaluation and dispositive action.

## BACKGROUND/FINDINGS:

- 1. That based on actual ground verification, the land subject of possession and occupation of late Clemencia Miciano identified in original Cadastral Lot No. 3848, Cad. 544-D, situated at Brgy. Laylay, Boac, Marinduque.
- 2. Per Cadastral survey executed on May 16 to June 15, 1977, which approved on June 9, 1979, the subject lot was surveyed in favor of the Municipality of Boac. It is containing an area of 3,214 square meters.
- 3. On February 8, 1993 Cad. Lot 3848, Cad. 544-D was subdivided under plan CSD 044001-011752-D, which was approved on February 8, 1993.
- 4. The parcel of land claimed by Clemencia Miciano is identified as Lot 3848-A, CSD-044001-011752-D with a highest lot number assigned Lot 22579, Cad. 544-D with an

- area of 997 square meters. The said parcel of land is covered by Patent No. P-044001-94-1063 issued in favor of said Clemencia Miciano on August 31, 1994.
- 5. The Lot 3848-B, CSD-044001-011752-D (Lot 22580), Cad. 544-D is a portion of the land wherein the government infrastructure erected such as Basketball court of Brgy. Laylay, Laylay Daycare Center, NFA warehouse, NFA Administration building and served as a road leading to Brgy. Hall of Laylay and of shoreline.
- 5. On September 19-23, 1998 the highest lot number #22580, Cad. 544-D iden. to Lot 3848-B, CSD-044001-011752-D was subdivided and segregated the 20.0 meters Salvage zone along the shoreline and the legal easement of the creek. This is in accordance with Department Administrative Order No. 97-05.
- 5.1 However, the assigned highest lot number #123087, Cad. 544-D, iden. to Lot 22580-A,CSD-04-017618, approved on March 23, 1999 surveyed in favor of Clemencia Miciano is in conflict or with the highest Lot number assigned under surveyed in favor of Sixto Olympia surveyed on November 17, 1998 and approved on December 17, 1998 involving Cad. Lot No. 3982-A, CSD-04-01768-D.
  - 5.2 That Lot No. 123087, iden. to 3982-A, CSD-04-01768-D is covered by Patent No. 044001-99-6157 issued in favor of Sixto Olympia on June 7, 1999.
- 6. On the other hand, Foreshore Lease Application No. 044001-83-99 of Clemencia Miciano along the shoreline adjacent of Lot No. 22580-B, CSD-04-017618, situated in Brgy. Laylay, Boac, Marinduque, was found and ascertained that the subject of FLA no. 044001-83-99 is falls within the Salvage Zone area, which is considered no build zone and is intended for public use purposes. Hence, the said application was rejected per Order dated February 26, 2001.

### COMMENTS AND RECOMMENDATION:

It is observed that the original Surveyed Claimant of Lot 3848, Cad. 544-D is the Municipality of Boac. When the land was subdivided, it was erroneously surveyed in favor of Clemencia Miciano, et al. Actual ground verification disclosed that the land subject of possession of Clemencia Miciano is Lot 3848-A, CSD-044001-011752-D (#22579), Cad. 544-D and 3848-B, CSD-044001-011752-D (#22580), Cad. 544-D is stands for the other claimant, the Municipality of Boac.

The Free Patent Application No. 044001-262-A filed by Clemencia Miciano over Lot No. 123087, Cad. 544-D iden. to Lot 22580, CSD-04-017618 is complicated due to assigned highest lot number is previously assigned and designated to Lot 3982-A, CSD-04-01768-D surveyed in favor of Sixto Olympia wherein the patent was issued in favor of Luis Olympia.




In view of the foregoing, it is respectfully recommended that the highest lot number of the subdivision lot under CSD-04-017618 shall be subject for amendment.

Further recommend, that considering that there is an still pending litigation in the Regional Trial Court under Civil Case No. 12-13 involving the same parcel of land, the legal counsel of heirs of Clemencia Miciano shall be advised to pursue litigation thereof to determine the true and lawful owner of the remaining portion of the land, for the Municipality of Boac is in open and continuous possession since 1921 up to present. It is in abeyance with Republic Act No. 10023 which mandated that the land subject of Free Patent Application must be in open, continuous possession and must be free from any land claims and conflicts.

I write in relation to your letter dated December 06, 2017. We are likewise wondering what has happened to the investigation conducted by your good office in this case.
